Proposed P4G DOCP Amendment to Schedule B - Bylaw No. 10088, The Saskatoon North Partnership for Growth Planning District Official Community Plan Amendment Bylaw, 2025

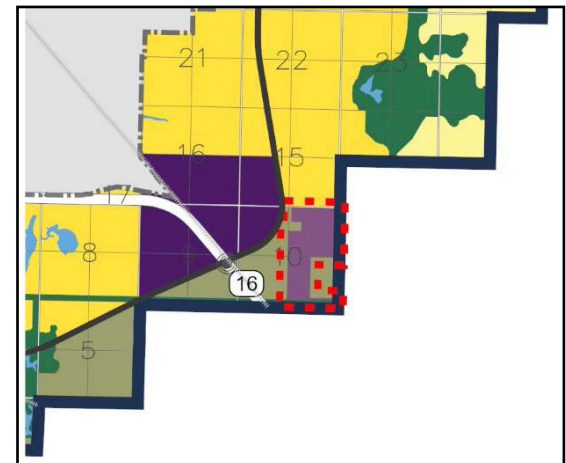
Saskatoon City Council will consider an amendment to the P4G Planning District Official Community Plan (Bylaw 9720) proposed by Patience Lake Business Park Ltd. to re-designate NE-10-36-04-W3, Ext. 1 & SE-10-36-04-W3, Ext. 15, located southeast of Saskatoon in the Rural Municipality of Corman Park. By way of Bylaw No. 10088, The Saskatoon North Partnership for Growth Planning District Official Community Plan Amendment Bylaw, 2025 (No. 1), the subject lands are proposed to be re-designated from ‘Agriculture’ to ‘Rural Commercial/Industrial’ as shown within the bold dashed line on Schedule B.

The Rural Municipality of Corman Park, Town of Osler, City of Martensville, City of Saskatoon, and City of Warman Councils will all consider amendments under the Planning and Development Act, 2007 to amend R.M. of Corman Park Bylaw 57/20, Town of Osler Bylaw 2020-08, City of Martensville Bylaw 12/2020, City of Saskatoon Bylaw 9720, and City of Warman Bylaw 2020-09, known as the P4G Planning District Official Community Plan. REASON FOR THE AMENDMENT

The proposed P4G District Official Community Plan amendment will re-designate NE-10-36-04-W3, Ext. 1 & SE-10-36-04-W3, Ext. 15 from ‘Agriculture’ to ‘Rural Commercial/Industrial’ to support a future rural commercial/industrial subdivision and development.
