- '65<sup>th</sup> Street East' to 'Millar Place' – to be applied to a now closed cul-de-sac in the Marquis Industrial area
- '59<sup>th</sup> Street East' to 'Faithfull Place' – to be applied to a now closed cul-de-sac in the Hudson Bay Industrial area

The following applicants were in attendance to speak further to their submissions:

- Don (and Lynn) Gibson – highlighted his father’s contributions and requested the Broadway area or East Saskatoon be considered for the Gibson name;
- Sam Sambasivam – elaborated on his nomination of the name ‘Kalra’, noting his friend’s countless achievements and enormous community involvement; and
- Keith Pfeil, Real Estate Services Manager, spoke briefly about the informal use of the name ‘Civic Square East’ and the intent of the application as having the name formally added to the Names Master List and applied to the municipal facility located at 202 – 4<sup>th</sup> Avenue North.

The gallery was excused at 10:10 a.m., prior to consideration of the applications.

Upon review of the policy and its guidelines and following discussion regarding all of the name submissions, it was noted:

- ‘Walko’, ‘Schmeiser’ ‘Mallough’ ‘Klein’ and ‘Loraas’, submissions do not meet criteria for addition to the list at this time – request additional civic contribution and community involvement/volunteerism.
- ‘Fireside’ submission – the Committee would like to see this name submitted as a separate application, interested in the history of the Saskatoon Fireside Singers from inception to present.
