**7.2.3 33rd Street - Boulevard Removal - Parking and Traffic
Operations (Files CK. 6320-1 and TS. 6320-1)**

Pursuant to earlier resolution, letters requesting to speak from
Tyler Gould and James Scott were provided.

The Committee passed a motion to also hear Ms. Anna Cole,
President of Mayfair/Hudson Bay Park/Kelsey-Woodlawn
Community Association.

General Manager, Transportation & Utilities Jorgenson presented
the report and answered questions of the Committee.

Mr. Gould, on behalf of the 33rd Street Business Improvement
District (BID), expressed concerns with adoption of the entire plan
as a general framework for the future of 33rd Street corridor but
indicated that there is no objection to the short-term
recommendations. The BID is concerned with the classification of
33rd Street corridor becoming a major arterial. He asked that more
robust consultation occur with the stakeholders.

Mr. Scott, business owner on 33rd Street and long-time resident of
Caswell Hill, indicated that 33rd Street is better left as is regarding
traffic flow and lane expansion in order to sustain the livelihood of
the businesses located in the 33rd Street Corridor. He further
indicated that the 33rd Street corridor needs to be more pedestrian
friendly.

Ms. Cole, President of the Community Association from Mayfair,
Hudson Bay Park, and Kelsey-Woodlawn, indicated that in order to
make 33rd Street viable for businesses to move in and invest, it

should be left as is. Ms. Cole suggested changes need to be made, but in other aspects of the neighbourhood, such as upgrading street lights and improving parking enforcement on 33rd Street.

The Committee wanted to highlight that conversations be held with stakeholders about pedestrian calming and the amount of traffic lanes between Avenues B and G and passed a motion in this regard.

That Ms. Anna Cole, President of Mayfair, Hudson Bay Park, Kelsey-Woodlawn, be permitted to speak to this item.

2. That the Administration continue consultations with the 33rd Street Business Improvement District and all abutting Community Associations, regarding the future of traffic improvements along 33rd Street.
