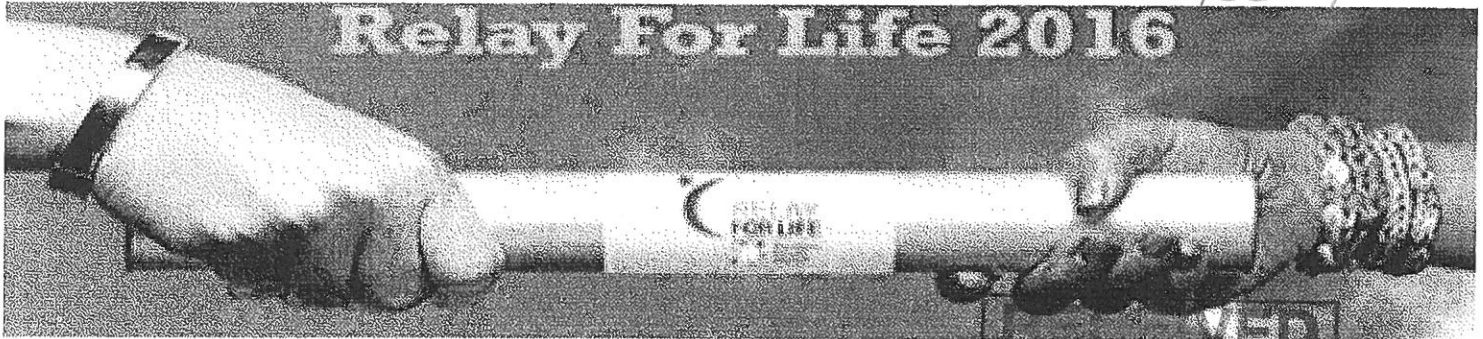

If required we would be happy to deliver notices of the event to the residential area surrounding the park.

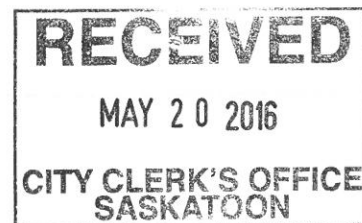
