

## BYLAW NO. 10075

### The Business Improvement Districts Levy Bylaw, 2025

The Council of the City of Saskatoon enacts as follows:

#### Short Title

1. This Bylaw may be cited as *The Business Improvement Districts Levy Bylaw, 2025*.

#### Definitions

2. In this Bylaw:
  - (a) **“33<sup>rd</sup> Street Business Improvement District”** means the 33<sup>rd</sup> Street Business Improvement District as designated in *The Business Improvement Districts Bylaw, 2022*;
  - (b) **“Broadway Business Improvement District”** means the Broadway Business Improvement District as designated in *The Business Improvement Districts Bylaw, 2022*;
  - (c) **“business improvement district”** means the Broadway Business Improvement District, the Downtown Business Improvement District, the Riversdale Business Improvement District, the Sutherland Business Improvement District and the 33<sup>rd</sup> Street Business Improvement District;
  - (d) **“Downtown Business Improvement District”** means the Downtown Business Improvement District as designated in *The Business Improvement Districts Bylaw, 2022*;
  - (e) **“Riversdale Business Improvement District”** means the Riversdale Business Improvement District as designated in *The Business Improvement Districts Bylaw, 2022*;
  - (f) **“Sutherland Business Improvement District”** means the Sutherland Business Improvement District as designated in *The Business Improvement Districts Bylaw, 2022*.

### **Purpose**

3. The purpose of this Bylaw is to set the rate of the levy authorized by section 23 of *The Business Improvement Districts Bylaw, 2022* for the year 2025.

### **Levy**

4. Pursuant to section 23 of *The Business Improvement Districts Bylaw, 2022*, a levy is imposed at the following rates for 2025:

(a)	33 <sup>rd</sup> Street Business Improvement District	0.13991%
(b)	Broadway Business Improvement District	0.18855%
(c)	Downtown Business Improvement District	0.08970%
(d)	Riversdale Business Improvement District	0.11034%
(e)	Sutherland Business Improvement District	0.10004%

### **Collection of Levy**

5. The levy imposed under this Bylaw may be collected in the manner provided for in *The Tax Enforcement Act*.

### **Duration**

6. The levy imposed by this Bylaw applies in the 2025 taxation year.

### **Coming Into Force**

7. This Bylaw comes into force on the day of its final passing.

Read a first time this 23<sup>rd</sup> day of April, 2025.

Read a second time this 23<sup>rd</sup> day of April, 2025.

Read a third time and passed this 23<sup>rd</sup> day of April, 2025.
