BYLAW NO. 6618

A bylaw of The City of Saskatoon entitled "A bylaw of The City of Saskatoon respecting paddling pools".

The Council of The City of Saskatoon enacts as follows:

1. This Bylaw shall apply to the following paddling pools which are located within The City of Saskatoon and owned by The City of Saskatoon:
 - a) A. H. Browne, 1603 Avenue D North, Saskatoon
 - b) Adelaide, 12 MacKenzie Crescent, Saskatoon
 - c) Albert, 506 Clarence Avenue, Saskatoon

 - f) Boughton - St. John, 1245 Schulyer Street, Saskatoon
 - g) Brevoort Park, 3 Webb Crescent, Saskatoon
 - h) Buena Vista, 1304 Victoria Avenue, Saskatoon
 - i) College Park, 133 Campion Crescent, Saskatoon
 - j) East College Park, 4215 DeGeer Street, Saskatoon
 - k) Eastview, 1130 - 1100 East Centre, Saskatoon
 - l) Fairhaven, 495 Forrester Road, Saskatoon
 - m) Greystone, 2711 Main Street, Saskatoon
 - n) Harold Tatler, 2520 Jarvis Drive, Saskatoon
 - o) Holliston, 1321 3rd Street, Saskatoon
 - p) Lakeview, 203 Whiteshore Crescent, Saskatoon
 - q) Lawson Heights, 748 Redberry Road, Saskatoon

 - ff) Westview, 2304 Richardson Road, Saskatoon
 - gg) Wildwood, 203 Rosedale Road, Saskatoon.

2. The Swimming Pool Regulations dated April 28, 1981 passed pursuant to The Public Health Act of Saskatchewan shall not apply to the paddling pools listed in paragraph 1 hereof unless the Medical Health Officer in writing otherwise directs.
- (a) Each pool shall be completely drained at the end of each day. The main drain valve of the pool shall remain open during the night.
 - (b) Before being refilled, the pool and the apron shall be scrubbed thoroughly and hosed down, special care being taken to scrub the area around the main drain.
 - (c) All debris, glass, leaves or other materials that could pollute the water or that could be hazardous to pool users shall be removed from the pool bottom and areas surrounding the pool, and properly disposed of.
 - (d) Each pool shall then be filled with fresh water from an approved supply.
 - (e) The water clarity of the pool shall be such that the main drain cover or grating is clearly visible from the edge of the pool.
 - (f) Disinfectant shall be added to the fresh water entering the pool in a quantity that is sufficient to establish a residual of free available chlorine of not less than two milligrams per litre within the ph range of 7.2 to 7.8.
 - (g) The free available chlorine shall be maintained throughout the pool at level mentioned in clause 2(f).
 - (h) The free available chlorine and ph shall be determined and recorded by the operator every two hours as long as the pool is open for use.
3. This bylaw shall come into force and take effect upon receiving approval pursuant to Section 83 of The Public Health Act of Saskatchewan.
