# **BYLAW NO. 8370**

# The Transit Fares Bylaw, 2004

The Council of The City of Saskatoon enacts:

#### Title

1. This Bylaw may be cited as The Transit Fares Bylaw, 2004.

#### Purpose

2. The purpose of this Bylaw is to set transit fares for The City of Saskatoon transit system including the Access Transit system.

#### Definitions

- 3. In this Bylaw:
  - (a) "adult" means a person over the age of 18 years;
  - (b) "child" means a person over the age of five and attending a recognized Public or Catholic elementary school or affiliated elementary school and is in a grade up to and including grade 8;
  - (b.1) "Discounted Bus Pass" means a bus pass issued under the Discounted Bus Pass Program;
  - (b.2) "Discounted Bus Pass Program" means a program sponsored by the Province of Saskatchewan wherein Saskatoon residents in receipt of benefits under the Saskatchewan Assistance Plan, the Transitional Employment Allowance, the Saskatchewan Employment Supplement and the Provincial Training Allowance are eligible for a Discounted Bus Pass. The Province of Saskatchewan's current sponsorship amounts to \$25.00 for each Discounted Bus Pass;

- (b.3) "Eco Pass" means a program sponsored by The City of Saskatoon and participating businesses under which employees of either The City of Saskatoon or the participating businesses are eligible for a monthly adult, 6-month adult or annual adult discounted bus pass;
- (c) "family" means a group of individuals related by blood, marriage or other legal status with a minimum of one adult and a maximum of two adults;
- (c.1) "Low Income Pass" means a discounted bus pass available for families that qualify based on a total household income that does not exceed the low income threshold amount established by Statistics Canada;
- (d) "post-secondary student" means a person who is a full-time attendee of an approved post-secondary institution located in the City of Saskatoon;
- (e) "preschool child" means a person aged 5 or under who is accompanied by an adult;
- (f) "Registered Access Transit Customer" means a person who has registered as an Access Transit Customer with The City of Saskatoon;
- (f.1) "semester" means the summer, fall or winter terms at a postsecondary institution;
- (g) "senior" means a person over the age of 64;
- (h) "student" means a person who is a full-time attendee of a recognized Public or Catholic high school or affiliated high school with proper high school photo identification;
- (i) Repealed Bylaw No. 10033 August 28, 2024
- (j) "U-Pass" means a transit pass issued for a semester to a postsecondary student or student pursuant to an Agreement between the educational institution and The City of Saskatoon.

## **Transit Fares**

4. The transit fares for The City of Saskatoon transit system are set out in Schedule "A".

5. The Transit Fares Bylaw No. 7449 is repealed.

#### **Coming Into Force**

6. This Bylaw shall come into force on January 1, 2005.
