Parking Restrictions & Enforcement Measures Reinstated May 25, 2020 As activity increases throughout our community with the Province's Re-Open Saskatchewan plan, the City has reinstated parking restrictions and enforcement measures as of May 25, 2020, including:

• **Public Pay Parking** - Customers are encouraged to use the WayToPark app to pay for parking. If the app is not an option, please ensure you follow public health guidelines when touching a FlexParking station.

• **Residential Parking Program (RPP)** - The City will continue to honour recently expired RPP permits until new permits are available for sale.

• Other Parking Restrictions - This includes the on-street parking time limit of 72 hours.
