## ZONING NOTICE

### **PROPOSED ZONING BYLAW TEXT AMENDMENT – BYLAW NO. 9807, THE ZONING AMENDMENT BYLAW, 2022 (NO. 3)**

Saskatoon City Council will consider an amendment to the City's Zoning Bylaw (No. 8770). By way of Bylaw No. 9807, The Zoning Amendment Bylaw, 2022 (No. 3), the Riverbank Slope Overlay District will be amended to provide for the construction of in-ground swimming pools on sites located in this Overlay District. The proposed amendment will require an application for an in-ground swimming pool in the Riverbank Slope Overlay District to include a report which provides a site-specific geotechnical review, demonstrating an engineered design to a Factor of Safety of 1.5 for the proposed development, a seepage analysis to present impact of a leak on the groundwater and Factor of Safety, and demonstrated leak mitigation provisions. The required report shall be prepared by a professional geotechnical engineer licensed to practice in the Province of Saskatchewan

**REASON FOR THE AMENDMENT** – The Riverbank Slope Overlay District provides development standards and regulations for specific sites adjacent to the South Saskatchewan River to avoid or minimize potential impacts of slope instability and subsidence on development, and to prevent injury and minimize property damage related to publicly and privately owned properties adjacent to the South Saskatchewan River. In-ground swimming pools are currently prohibited in the Riverbank Slope Overlay District.

Following implementation of the Riverbank Slope Overlay District in 2019, further review was undertaken to evaluate options for the development of in-ground swimming pools in this Overlay District. The proposed amendment will implement development standards and regulations identified during the review to provide for the construction of in-ground swimming pools in the Riverbank Slope Overlay District.
