


ZONING NOTICE

ROSEWOOD NEIGHBOURHOOD PROPOSED ZONING BYLAW AMENDMENT – BYLAW NO. 9784, THE ZONING AMENDMENT BYLAW, 2021 (NO. 17)

Saskatoon City Council will consider an amendment to the City's Zoning Bylaw (No. 8770) proposed by Boychuk Investments Ltd. to rezone land in the Rosewood neighbourhood. By way of Bylaw No. 9784, The Zoning Amendment Bylaw, 2021 (No. 17), subject sites adjacent to Rosewood Drive are proposed to be rezoned from R1A – One-Unit Residential District to R2 – One and Two-Unit Residential District.

LEGAL DESCRIPTION - Ptn Block DD, Plan No. 102028586



REASON FOR THE AMENDMENT – Both the R1A District and R2 Districts would provide for low density residential development in the form of detached One-Unit Dwellings and related community uses. Rezoning to an R2 District would permit Two-Unit Dwellings and narrower lot development than what is permitted in the R1A District.


ROSEWOOD NEIGHBOURHOOD CONCEPT PLAN - PROPOSED AMENDMENT

Saskatoon City Council will consider an amendment to the Rosewood Neighbourhood Concept Plan proposed by Boychuk Investments Ltd. The proposed amendment would provide for a change in the land use for sites located adjacent to Rosewood Drive as shown on the map below from 'Multi Family' to 'Single Family'. The proposed amendment would also provide for the addition of a local road to service the subject sites.

REASON FOR THE AMENDMENT – The proposed Rosewood Neighbourhood Concept Plan amendment, in conjunction with a Zoning Bylaw amendment, would provide for the future subdivision and development of the subject lands for One and Two-Unit Dwellings and related community uses. The sites are currently identified for the development of a Dwelling Group on the Rosewood Neighbourhood Concept Plan.
