
PUBLIC NOTICE

The City of Saskatoon is proposing the following partial closure of Caledonia Avenue, Transfer Avenue, Wabash Avenue, Orth Avenue, Cordage Avenue, lanes and 12th Street adjacent to 11th Street – AgPro Industrial Neighbourhood.

Location: Portions of Caledonia Avenue, Transfer Avenue, Wabash Avenue, Orth Avenue, Cordage Avenue, lanes and portion of 12th Street West adjacent to 11th Street West and approximately 600 meters west of the intersection of 11th Street and Fairlight Drive.

Please Note: None of these streets and lanes proposed to close have ever been built. No roads or lanes will physically close.





BRIGHTON NEIGHBOURHOOD PROPOSED ZONING BYLAW AMENDMENT - BYLAW NO. 9763

Saskatoon City Council will consider an amendment to the City's Zoning Bylaw (No. 8770) proposed by Dream Development in the Brighton neighbourhood. By way of Bylaw No. 9763, The Zoning Amendment Bylaw, 2021 (No. 12), the subject sites located southeast of Brighton Gate and southwest of Taube Avenue are proposed to be rezoned from FUD - Future Urban Development District and FUD - Future Urban Development District (H) to R1A - One-Unit Residential District, R1B - Small Lot One-Unit Residential District, R2 - One and Two-Unit Residential District and RMTN - Townhouse Residential District.

LEGAL DESCRIPTION

- Portion of Block M1, M2, LL1, LL2 and LL3 Plan 102343979
- Block M4 and M5 Plan 102343979
 - Portion of SE 30-36-04-W3



REASON FOR THE AMENDMENT - The proposed rezoning would provide for residential subdivision and development that aligns with the approved Brighton Neighbourhood Concept Plan.

The zoning amendments would provide for:

- residential development in the form of one-unit dwellings as well as related community uses on sites to be zoned R1A District;
- small lot residential development in the form of one-unit dwellings as well as related community uses on sites to be zoned R1B District;
- residential development in the form of one and two-unit dwellings as well as related community uses on sites to be zoned R2 District; and
- comprehensively planned low to medium density multiple-unit dwellings in the form of townhouses, dwelling groups and other building forms, as well as related community uses on sites to be zoned RMTN District.
