SL&P SASKPOWER: NEW ELECTRICAL RATES EFFECTIVE SEPTEMBER 1

City Council at its August 29, 2022, meeting approved the *Standing Policy Committee on Environment, Utilities and Corporate Services* recommendation to match SaskPower's approved electrical rate increases. The new rates are in effect as of September 1, 2022; a second rate increase is planned for April 1, 2023. The Federal Carbon Charge is anticipated to increase on January 1, 2023.

The City of Saskatoon (and Saskatoon Light & Power (SL & P) as a reseller of electricity), matches the rates established by SaskPower. This ensures equality between utility customers regardless of where they live – either within SL&P's or SaskPower's service provider areas.

If you're uncertain of your electrical service provider, review your monthly utility bill or call Saskatoon Light & Power at 306-975-2414 during regular business hours.
