PROPOSED ZONING BYLAW AMENDMENT - BYLAW 9925

Saskatoon City Council will consider amendments to the City's Zoning Bylaw (No. 8770) by way of Bylaw No. 9925, The Zoning Amendment Bylaw, 2023 (No. 19);

The City of Saskatoon is undertaking a comprehensive review of the Zoning Bylaw to align it with identified strategic priorities, current trends, and changes to provincial legislation. The proposed amendment addresses the requirement for on-site waste spaces for multi-unit residential developments.

The Zoning Bylaw currently requires one on-site waste space per 40 dwelling units for multiple-unit dwellings and dwelling groups. This provision has proved to be difficult to provide related to the overall site design. The proposed amendment will require one on-site waste space for multiple-unit dwellings and dwelling groups, in alignment with the existing requirements for all other uses.


