2023 PROPERTY ASSESSMENT ROLL & 30-DAY ASSESSMENT REVIEW & APPEAL PERIOD JANUARY 3 TO FEBRUARY 3, 2023

According to Section 187 of *The Cities Act*, notice is hereby given that the Property Assessment Roll for the City of Saskatoon for the year 2023 has been prepared and will be open for public inspection at the Assessment and Valuation Office of Corporate Revenue, beginning January 3, 2023, between the hours of 8 a.m. and 5 p.m., excluding Saturdays, Sundays and statutory holidays.

The Assessment Office is located at 325 3rd Ave N, one block north of City Hall. You may also view the roll online at **saskatoon.ca/taxtool**.

The City's 2023 Assessment Roll will be open for inspection from January 3 to February 3, 2023. This timeframe also marks the 30-Day Assessment Review & Appeal Period.

The 2023 Assessment Notices will be mailed on January 3, 2023. The City will mail a 2023 Assessment Notice only if there has been a change, since January 1, 2022, to your property's assessment, tax status, or ownership. (Bylaw No. 8067, The Assessment Notices Bylaw, 2002). A property owner does not need to receive an assessment notice in 2023 to review the roll or file a formal assessment appeal in 2023.

Any person having an interest in any property who wishes to appeal the valuation, classification or content of the relevant notices to the Board of Revision is required to file their appeal in writing or <u>online</u>, together with the appropriate fee during the **30-Day Assessment Review & Appeal Period January 3 - February 3, 2023**.

Most assessment-related questions can be resolved by discussing your property with an assessor before proceeding with a formal assessment appeal with required fees. Email assessmentsubmit@saskatoon.ca or call **306-975-3240**.
