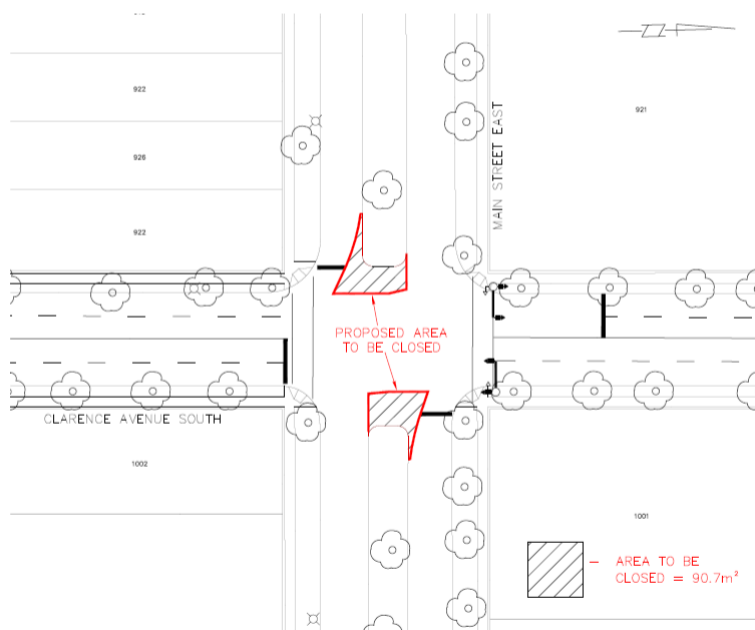
PUBLIC NOTICE

Proposed Closure of Road – Portion of Main Street East and Clarence Avenue South

The City of Saskatoon is proposing the following road closure at the Main Street East/Clarence Avenue South intersection – Nutana and Varsity View Neighbourhoods.

This closure is to prohibit Main Street East eastbound and westbound through and left turn movements at Clarence Avenue South. 2022 W̱ichitowin Indigenous Engagement Conference

November 28 & 29, 2022, TCU Place, Saskatoon

In-person tickets to this year's conference are now SOLD OUT but tickets to attend virtually from 8:00 am - 4:30 pm on both days are still available. The valuable event is for anyone working toward respectful Indigenous engagement and inclusion.

About the 2022 Conference: Between 2007 and 2015, the TRC Commission travelled to all parts of Canada to bear witness to residential school experiences; to create a permanent historical record; and to engage and educate the public about Survivor experiences and intergenerational impacts.

Bearing Witness is the theme of this year's conference. In keeping with the oral traditions of Indigenous Peoples, witnesses are called upon to be the keepers of history when a significant event happens. Bearing Witness is a way to acknowledge, validate, and legitimize the Truth.

This year's speaker line-up includes the Truth and Reconciliation Commissioners and Chief Cadmus Delorme of Cowessess First Nation.

An annual event since 2014, the **W̱ichitowin Conference** provides a platform for Residential School Survivors and others with acquired or lived experience to share their teachings. It also provides a forum to share resources & tools to support culturally respectful organizations. W̱ichitowin is a Cree/Saulteaux term meaning "to help each other/to work together".

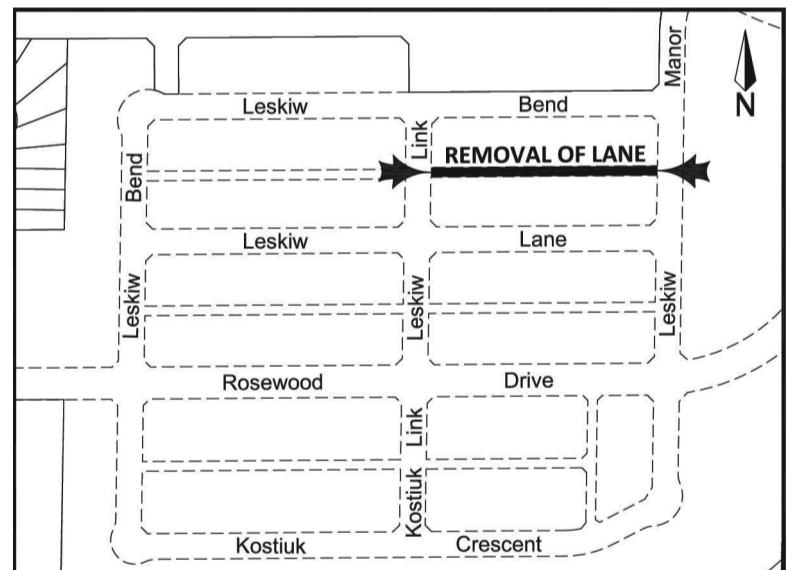

NEIGHBOURHOOD CONCEPT PLAN NOTICE

ROSEWOOD NEIGHBOURHOOD CONCEPT PLAN – PROPOSED AMENDMENT

Saskatoon City Council will consider an amendment to the Rosewood Neighbourhood Concept Plan proposed by Arbutus Properties. The proposed amendment would remove one back lane in the block between Leskiw Bend and Leskiw Lane in the southern part of the neighbourhood, as shown on the map below.

REASON FOR THE AMENDMENT – The area is currently undeveloped and the proposed Rosewood Neighbourhood Concept Plan amendment, in conjunction with a Zoning Bylaw amendment (Bylaw No. 9850), would provide for the future subdivision and development of the subject lands for One Unit Dwellings and related community uses. The sites are currently identified for Single Family development on the Rosewood Neighbourhood Concept Plan.
