According to Section 187 of *The Cities Act*, notice is hereby given that the Property Assessment Roll for The City of Saskatoon for the year 2022 has been prepared and will be open for public inspection at the Assessment and Valuation Office of Corporate Revenue, beginning January 4, 2022, between the hours of 8:00 a.m. and 5:00 p.m., excluding Saturdays, Sundays and statutory holidays.

The City's 2022 Assessment Roll will be open for Inspection from January 4 to February 4, 2022.

The 2022 Assessment Notices will be mailed on January 4, 2022. The City will mail an Assessment Notice only if there has been a change from the previous year. (*Bylaw No. 8067, The Assessment Notices Bylaw, 2002*).

Any person having an interest in any property who wishes to appeal the valuation, classification or content of the relevant notices to the Board of Revision is required to file the appeal in writing or online, together with the appropriate fee **no later than February 4, 2022**.
