Discretionary Use Application – Childcare Centre (Maximum 12 Children) – 546 Marlatte Lane

Recommendation

That a report be submitted to City Council recommending that at the time of the public hearing, City Council consider the Administration's recommendation that the application, submitted by Najma Jafri requesting permission to operate a childcare centre with a maximum of 12 children at 546 Marlatte Lane, be approved, subject to the following conditions:

- 1. That the applicant obtain a Development Permit and all other relevant permits and licenses; and
- 2. That the final building and development plans be substantially in accordance with the plans submitted in support of this Discretionary Use Application.

Topic and Purpose

The purpose of this report is to consider a Discretionary Use Application from Najma Jafri to operate a childcare centre with a maximum of 12 children at 546 Marlatte Lane.

Report Highlights

- The proposed childcare centre meets all applicable Zoning Bylaw No. 8770 (Zoning Bylaw) requirements.
- 2. The proposal is not anticipated to significantly impact the surrounding land uses.

Strategic Goal

This application supports the City of Saskatoon's (City) Strategic Goal of Quality of Life as the proposal offers increased child care opportunities within a neighbourhood setting.

Background

The property located at 546 Marlatte Lane is in the Evergreen neighbourhood and is zoned R1B – Small Lot One-Unit Residential District under the Zoning Bylaw (see Attachment 1). A childcare centre is considered a discretionary use in the R1B District. Najma Jafri has submitted an application requesting City Council's approval to operate a childcare centre with a maximum of 12 children at this location.

Report

Zoning Bylaw Requirements

The Zoning Bylaw defines a childcare centre as "an establishment providing for the care, supervision, and protection of children, but does not include the provision of overnight supervision." The applicant is proposing to operate a childcare centre from Monday to Friday during standard work hours. The childcare centre will be operated out of the applicant's home at 546 Marlatte Lane (see Attachment 2).

Discretionary Use Application – Childcare Centre (Maximum 12 Children) – 546 Marlatte Lane

Surrounding properties consist of one-unit dwellings. A childcare centre with 12 children under care requires 42 m² of on-site outdoor play space; the site plan indicates that more than twice that amount of space is available. The required parking spaces will be provided in a detached garage in the rear yard. No exterior alterations will be undertaken that would be inconsistent with the residential character of the neighbourhood.

Conclusion

The proposed childcare centre at 546 Marlatte Lane meets all applicable Zoning Bylaw provisions and is not anticipated to have any significant impact on surrounding land uses.

No concerns were noted by other divisions that would preclude this application from proceeding (see Attachment 3).

Options to the Recommendation

City Council could deny this Discretionary Use Application. This option is not recommended, as the proposal complies with all applicable Zoning Bylaw requirements and has been evaluated as a discretionary use, subject to the provisions in Section 4.7 of the Zoning Bylaw.

Public and/or Stakeholder Involvement

Notices to property owners within a 75 metre radius of the site, as well as to the Evergreen Community Association, were mailed out in May 2017 to solicit feedback on the proposal. To date, one property owner called to express concerns with uses of property beside one-unit dwellings in the area. The discretionary use process was explained to the property owner, as well as the other permitted and discretionary uses allowable in the zoning district. No further concerns have been expressed.

A community engagement summary is included as Attachment 4.

Communication Plan

No further communication is planned beyond the stakeholder involvement noted above and the required notice for the public hearing.

Other Considerations/Implications

There are no policy, financial, environmental, privacy, or CPTED implications or considerations.

Due Date for Follow-up and/or Project Completion

Follow-up is not required.

Public notice is required for consideration of this matter, pursuant to Section 11(b) of Public Notice Policy No. C01-021.

Discretionary Use Application – Childcare Centre (Maximum 12 Children) – 546 Marlatte Lane

Once this application has been considered by the Municipal Planning Commission, a date for a public hearing will be set. The Planning and Development Division will give notice, of the public hearing date, by mail, to the Evergreen Community Association and assessed property owners within 75 metres of the subject site. 



Comments from Internal Administrative Review for Discretionary Use Application Childcare Centre (Maximum 12 Children) – 546 Marlatte Lane

1. <u>Transportation and Utilities Department Comments</u>

The proposed Discretionary Use Application is acceptable to the Transportation and Utilities Department.

2. <u>Building Standards Division Comments</u>

The Building Standards Division has no objection to the proposed Discretionary Use Application. Please note, a building permit will be required if any construction is occurring. This application has been evaluated based on the number of children under care not being more than 12 and no overnight care of children being provided.

Community Engagement Summary Proposed Discretionary Use – Childcare Centre (Maximum 12 children) 546 Marlatte Lane

Project Description

The Community Services Department has received a Discretionary Use Application to operate a childcare centre with a maximum of 12 children at 546 Marlatte Lane. Property owners in the Evergreen neighbourhood, specifically those within 75 metres of the subject site, have the opportunity to learn about the proposed development and the discretionary use process, and have the opportunity to comment on the proposal and ask any questions that they may have.

Community Engagement Strategy

Notices to property owners within a 75 metre radius of the subject site were sent out on May 10, 2017. Notices were also sent to the Evergreen Community Association, the Ward Councillor, and the Community Consultant.

The purpose of the notice was to inform, and consult with, the nearby residents. Interested or concerned individuals were provided with an opportunity to learn more about the proposal and to provide perspective and comments for consideration.

Summary of Community Engagement Feedback

One response was received from the notice provided to nearby property owners. The respondent was concerned that a property in this zoning district could be used for the purpose of a childcare centre but not for the purposes of having three suites. The permitted and discretionary uses allowable in the R1B zoning district were explained to the respondent as well as the process for discretionary use applications and the requirement for public notification. The respondent was advised of their opportunity to provide further comment at the public hearing, should they wish. No further concerns were expressed.

Next Steps

All feedback from the public notification process will be summarized and presented as part of the report to the Municipal Planning Commission (MPC) and City Council.

Once this application has been considered by the MPC, a date for a public hearing will be set, and notices will be sent to property owners within 75 metres of the subject site and to

City of Saskatoon – Debt Limit

Recommendation

That pursuant to Section 133 of *The Cities Act*, the Administration be authorized to request the Saskatchewan Municipal Board to re-establish the debt limit for the City of Saskatoon at \$558M.

Topic and Purpose

The purpose of this report is to obtain City Council approval to re-establish the City of Saskatoon's (City) debt limit with the Saskatchewan Municipal Board (SMB) at the current level.

Report Highlights

- 1. The SMB requires municipalities to establish their debt limit on a periodic basis.
- 2. The City is requesting to the SMB that the debt limit remain at the level that was established in October 2014, which is \$558M.

Strategic Goal

The information in this report supports the Strategic Goal of Asset and Financial Sustainability by managing debt and the current debt limit to protect the City's credit rating.

Background

On October 15, 2014, the SMB advised the Administration that the debt limit was established at \$558M. The debt limit was calculated based an amount equal to the City's own source annual revenue. This is consistent with the SMB's calculation for municipalities. Own source revenue comes from property taxes, utilities, user fees and earnings on investments. Own source revenue does not include conditional or unconditional grants, grants in lieu of property taxes or SaskPower surcharges. The \$558M is based on the calculation from 2013 Financial Statements. This debt limit is subject to review by December 31, 2017.

Report

The SMB requires the Administration to submit a request to the Local Government Committee to have the City's debt limit established for a further period effective January 1, 2018. A term expiration date is used by the SMB to ensure the debt limit established for the municipality continues to be fiscally sustainable. It also provides assurance to financial institutions that rely on the SMB's establishment of the debt limit that the debt limit is periodically reviewed.

Based on borrowing required for approved capital projects and expected future capital projects, the future debt requirements of the City fall within the already established debt limit. Therefore, the Administration is recommending that the debt limit be reestablished at the current limit.

Options to the Recommendation

City Council can choose not to authorize the re-establishment of the debt limit. The Administration does not recommend this option, as the City would become non-compliant with provincial legislation and the SMB putting the City's credit rating at risk.

Policy Implications

Policy No. C03-027, Borrowing for Capital Projects, states, in part, that "all decisions with respect to incurring additional internal and external debt shall be evaluated for the perspective of not adversely affecting the City's overall credit worthiness (as measured by its external credit rating)."

The Administration does not feel that the decision to re-establish the debt limit at the same amount that has been currently approved will have an effect to the City's credit worthiness.

Other Considerations/Implications

There are no financial, environmental, privacy, or CPTED implications or considerations. Neither public and/or stakeholder involvement nor a communication plan is required.

Due Date for Follow-up and/or Project Completion

Following City Council approval, the Administration will send a letter to the SMB requesting the debt limit be re-established at \$558M effective January 1, 2018.

PUBLIC NOTICE INTENT TO RE-ESTABLISH CURRENT DEBT LIMIT

City Council will consider a report from Administration at the Council meeting to be held on Monday, August 28, 2017 at 6:00 p.m., Council Chambers, City Hall recommending:

That Pursuant to Section 133 of *The Cities Act*, City Administration be authorized to request the Saskatchewan Municipal Board to re-establish the debt limit for the City of Saskatoon at \$558M.

Public notice is given, pursuant to Section 3(e) of Policy No. C01-021 (The Public Notice Policy).

Proposed Closure of Right-of-Way – Portion of Zimmerman Road between Market Drive and Meadows Parkway – Rosewood Neighbourhood

Recommendation

- 1. That City Council consider Bylaw No. 9462, The Street Closing Bylaw, 2017 (No. 11);
- 2. That after closure a portion of this land will be designated Municipal Buffer and the remainder will be consolidated with Arbutus Properties property adjacent to the east (Parcel L); and
- 3. That all costs associated with the closure be paid for by the applicant, including Solicitor's fees and disbursements.

Topic and Purpose

This report requests approval to close a portion of Zimmerman Road between Market Drive and Meadows Parkway. This closure will allow the applicant to consolidate a portion of the closed right-of-way with their adjacent property for future commercial development. This plan is in accordance with the Rosewood Neighbourhood Concept Plan approved in 2014.

Report Highlights

Arbutus Properties requests that a portion of Zimmerman Road between Market Drive and Meadows Parkway be closed. This road closure will facilitate development in the Rosewood neighbourhood. If approved, a portion of the road closure will be transferred to Arbutus Properties in exchange for a payment to the Province of Saskatchewan, as the Province had previously purchased road widening in anticipation of a highway construction project.

Strategic Goal

This report supports the Strategic Goal of Sustainable Growth as the closure will allow for development of the Rosewood neighbourhood.

Background

The Rosewood Neighbourhood Concept Plan, approved by City Council in May of 2014, illustrates that a portion of Zimmerman Road right-of-way be closed to accommodate the continued development of the Rosewood neighbourhood. The Province had previously purchased land to widen the right-of-way in anticipation of a highway construction project. Now, the Province is no longer planning a highway within this right-of-way and it is within the City boundary. Now named Zimmerman Road, and within the City boundary, a detailed design has been completed, the road has been constructed to urban standards, and a right-of-way width of 55 metres is required. The remaining five metres of right-of-way has been allocated to a one metre buffer strip on

either side, and a three metre strip to be consolidated with the Arbutus Properties lands to the east.

In June 2016, the City of Saskatoon was contacted by Webster Surveys, on behalf of Arbutus Properties, stating their interest in closing and purchasing a portion of Zimmerman Road to consolidate with their adjacent property.

Administration reviewed and determined a portion of Zimmerman Road could be closed as it was no longer needed for transportation purposes.

Report

The Ministry of Highways and Infrastructure has indicated compensation is required. The applicant has agreed to compensate the Province of Saskatchewan.

Closure of Portion of Road





History

Lease Renewal of City-Owned Land – Potash Corporation of Saskatchewan Inc.

Recommendation

That the Standing Policy Committee on Finance recommend to City Council that the Administration be authorized to proceed with a Lease Renewal Agreement with Potash Corporation of Saskatchewan Inc. for a small portion of Public Reserve land along the South Saskatchewan River near the weir for the continued use as a raw water intake and pumping station in accordance with terms set out in this report.

Topic and Purpose

The purpose of this report is to receive City Council approval to renew the land lease with Potash Corporation of Saskatchewan Inc. (PCS) for 33,580 square feet of City of Saskatoon (City) owned riverbank land (Attachment 1) to continue to operate a raw water pumping station and associated pipeline.

Report Highlights

- 1. PCS wishes to renew the lease agreement and continue to use the location to operate the water pumping station.
- 2. Terms acceptable to both parties have been reached.

Strategic Goals

This report supports the long-term strategy of increasing revenue sources and reducing reliance on residential property taxes under the Strategic Goal of Asset and Financial Sustainability. This also supports the long-term strategy of planning collaboratively with regional partners and stakeholders under the Strategic Goal of Sustainable Growth.

Background

On June 1, 1964, the City and PCS (formerly Potash Company of America) entered into a 50-year lease agreement for City-owned land as a site for the installation, maintenance, and operation of a raw water pumping station and pipeline. This lease expired on May 31, 2014. The pipeline continues along CP Railway tracks to PCS's Patience Lake Mine and transports raw water for use in its mining operations.

Report

PCS Lease Renewal

In discussing lease renewal options with PCS, the following points were considered:

- Upon expiration of the previous lease, the General Manager of the Patience Lake Mine identified PCS's desire and intention to continue leasing the land.
- Patience Lake is a solution mine and requires raw water for its mining operations.

- PCS is responsible to hold and maintain all required licenses permitting water extraction from the South Saskatchewan River.
- The land in question is designated as Public Reserve land and the terms of the lease meet the requirements for the leasing of Public Reserve land under The Planning and Development Act, 2007 and The Dedicated Lands Regulations, 2009.

Terms of Lease Renewal Agreement

Notable terms of the agreement include:

- Lease backdated to commence June 1, 2014.
- Annual lease rate increased from \$150 to \$3,089 (first year of lease term) and increases at a rate of 2.5% per annum.
- Term is 25 years, expiring May 31, 2039.
- Use of land is limited to raw water intake, pumphouse station and associated sub-surface pipeline.
- PCS cannot provide water to any person or corporation within 8 kilometers of City corporate limits without City consent.
- PCS acknowledges the pending hydropower generation project, and that if it
 proceeds, will necessitate the relocation of the raw water intake and related
 pumphouse and pipeline. The City has agreed that investigations into a
 suitable relocation site are to be considered as part of the overall project.
 PCS acknowledges it is responsible for all costs associated with those
 investigations, design, and relocation of the facilities.
- City can terminate the lease upon 4 years' notice; PCS can terminate upon 1 year's notice.

Options to the Recommendation

City Council can choose not to approve the lease renewal. The Administration does not recommend this option as the raw water intake, pumphouse and associated pipeline are key elements to the continued operation of the Patience Lake solution mine.

Public and/or Stakeholder Involvement

The Water Security Agency, Saskatoon Water, and Saskatoon Light & Power were contacted regarding comments or concerns, none of which were noted.

Financial Implications

Adopting the recommended Lease Renewal Agreement would yield total revenue of approximately \$107,000 over the 25 years, averaging approximately \$4,280 per annum over the Term. There is no cost to be borne by the City for this project. Revenue received from the lease will be deposited into the Dedicated Lands Account.

Other Considerations/Implications

There are no policy, environmental, privacy, or CPTED implications or considerations, and a communication plan is not required.

Due Date for Follow-up and/or Project Completion

Due date for follow-up and/or completion is not required.






