INDUCTION CEREMONIES FOR MAYOR AND ALDERMEN

The City Clerk called the meeting to order and introduced Dr. Michael Tai, who presented a prayer of invocation.

The Honourable Madam Justice Marion Wedge, Justice of the Saskatchewan Court of Queen's Bench, administered the Declaration of Office to His Worship Mayor Henry Dayday and placed on his shoulders the Chain of Office of the Mayor of The City of Saskatoon, and charged him with the duties of the Chief Executive Office of the City.

A prayer for the Mayor and his Office was said by Dr. Michael Tai.

The City Clerk then called forward Aldermen Birkmaier, Cherneskey, Dyck, Hawthorne, Mann, McCann, Mostoway, Penner and Thompson, individually, who took their Declaration of Office before the Mayor, following which His Worship the Mayor charged the Aldermen with the responsibility to employ themselves in their office in a diligent, faithful and impartial manner, and welcomed them as members of City Council.

At the conclusion of the salutations, the Aldermen took their seats and His Worship the Mayor took his seat on the dais. His Worship the Mayor invited the members of the Administration to take their seats within the Bar.

INAUGURAL ADDRESS

His Worship Mayor Dayday noted that Alderman Waygood was not able to be present at this meeting and will be taking her Declaration of Office at the next regular meeting of City Council.

His Worship the Mayor expressed his appreciation to Madam Justice Wedge and Dr. Tai for their part in the ceremonies.

His Worship Mayor Dayday noted that since a ward system is not in place, the Aldermen, in the past, agreed to an informal ward system. He asked that all returning Aldermen continue to represent the wards they have represented in the past, and that Alderman Birkmaier assume the responsibility for Ward 2 and Alderman McCann assume the responsibility for Ward 5.

Congratulations were expressed by the Mayor to all of the Aldermen who were elected to City Council during the October civic election. A special welcome was expressed to the two new, but experienced, Aldermen -- Donna Birkmaier and Peter McCann. He stated that the Aldermen have committed themselves to serving the citizens of Saskatoon for the next three-year period and that he looked forward to working with all of the Aldermen to give the citizens of Saskatoon the best possible civic government.

His Worship Mayor Dayday stated that even though the economy has been slow during the past few years, the City has been able to move forward and make several positive changes. He indicated that he believed that the economy will begin to improve and greater activity will be seen in the city. As a City, sights should be set on moving forward and providing the best possible service for the future. This means that Council should work with the administration, senior levels of government, local organizations and the public to ensure that together the energies and resources are directed towards maximizing the benefits for the city.

Mayor Dayday noted that, initially, Council will be meeting to approve a Capital Works Budget. Many decisions that are made over the next two months will impact upon 1992. Such projects as the twinning of Circle Drive from 22nd Street to 33rd Street will have a high priority. Early in 1992, Council will be reviewing and approving the Operating Budget. This budget will impact upon the services provided and the level of taxation that will be required to provide these services. He noted that everyone is aware of the financial difficulty that is being experienced by many of the businesses and residents in the city, and it will be incumbent upon Council to look at the feasibility of bringing in a budget that reflects a zero mill rate increase and the impact that this would have on services. He stated that the City has been a very prudent manager of financial resources and should continue as such.

With the civic election still fresh in everyone's mind, His Worship the Mayor stated that he will be asking the new provincial government to look into reinstating the ward system. There has been a lot of frustration expressed by the voters in terms of the long ballot. It is fortunate that there is a fairly reasonable Aldermanic representation of areas across the city.

Mayor Dayday indicated that the City deals with a multitude of issues on a month-to-month basis and has also embarked upon an open approach to the standing committee meetings so that the public has greater accessibility to Council.

Mayor Dayday stated that each member of City Council has a particular philosophy towards civic politics and politics in general. He noted that, in the past, the use of Council Chambers to perpetuate political philosophies that may have little or nothing to do with Council business has been minimized, and that he believed the people of the city elect Council members to deal with civic issues. Mayor Dayday stated that he hoped that members of City Council would agree and will continue to keep in mind the interest of civic policies and programs as the major purpose.

In conclusion, Mayor Dayday thanked all those present and those watching at home on television, and indicated that he looks forward to working with all the people in the city over the next term.

The Planning Department advises that, in its opinion, the conversion will not significantly reduce the availability of rental accommodation in the area, nor will the conversion create significant hardship for any or all of the tenants of the existing premises. Canada Mortgage and Housing Corporation conducts a semi-annual rental market survey each April and October. The latest April survey indicates that for the westerly part of Saskatoon, the vacancy rate for apartments was 17.5% and for row housing, 19.9%. Even if the vacancy rates have changed since the survey was conducted, the vacancy rate in this part of the City is still high. In addition, the units in this dwelling group were vacant when the renovations were started and thus, the conversion will not create a significant hardship for any or all of the tenants of the existing premises (as there were none). The form of development in this project is also considered suitable for conversion."

The Administration contacted officials of the Provincial Government to determine whether the certificate should be issued to the Saskatchewan Housing Corporation (as indicated in the application and the associated documents) or to the Saskatchewan Department of Community Services. As a result, property owners and trailer owners will, excluding the timing consideration, be treated equally with respect to yearly local government tax/fee adjustments.

**D4) Naming of Parks - John Avant
(File No. CC 4206-0)**

Currently, the City of Saskatoon has two policies relating to the naming of streets, buildings and parks, being Policy 09-008 (Naming Saskatoon Parks) and Policy C01-008 (Naming of Streets and Buildings). The Audit Services Department has prepared a draft consolidation of the two policies and this consolidation has been forwarded to the Planning and Development Committee for review.

Under Policy 09-008 (Naming Saskatoon Parks), the Parks and Recreation Board had been delegated the responsibility of recommending names to City Council for naming parks. With the reorganization of civic services to create the Civic Buildings and Grounds Department and the Leisure Services Department, the Parks and Recreation Board is longer in existence. The proposed draft policy will address this issue. However, pending the report from the Planning and Development Committee determining the appropriate mechanism for considering names, the Administration would respectfully request that Council consider naming a park after the former Director of Finance, John Avant.

John Avant began his career with the City of Saskatoon on May 1, 1949, as City Comptroller and retired on April 30, 1979, as Director of Finance after exactly 30 years of service. A chartered accountant by profession, Mr. Avant graduated with great distinction from the College of Commerce in 1942 and then served overseas with the Canadian Army until 1945. He was employed by a local chartered accountant firm until his employment with the City of Saskatoon. In addition to his service to the City of Saskatoon, Mr. Avant was the treasurer of Jubilee Residences for 33 years, treasurer of St. James Anglican Church, and Honourary Bursar for Emmanuel College, University of Saskatchewan. With the advent of computer technology he remained one of the last of a vanishing breed of accountants who could do multiple column addition by running his fingers

down a column of figures, and was often called upon to correct errors on adding machine tapes.

A quiet and unassuming individual, Mr. Avant was largely responsible for the financial policies that the civic administration still adhere to, which has resulted in the establishment of reserves and the high credit rating that the City of Saskatoon enjoys.

The Administration, therefore, feels that it would be appropriate that the park at the end of the lake in Erindale be named "John Avant Park." A sketch is attached indicating the location of the park proposed to be named after Mr. Avant.

RECOMMENDATION: that City Council name the park area at the eastern end of the lake in Erindale subdivision the "John Avant Park."

**D5) Employee and Family Assistance Program
(File No. CC 4690-3)**

The City of Saskatoon Employee and Family Assistance Program has been in existence since January, 1990. Since its introduction, utilization of the program has continually increased. Because of the demand for services, it became obvious by mid-1991 that it could not be sustained at its current level with the existing financial structure. The Board of Directors, consisting of both civic union and management representatives, made the difficult decision to limit the use of the program to existing clients, and to only the most severe new cases. This resulted in the deferring of requests for assistance from civic employees.

The Employee and Family Assistance Program is considered a resounding success by civic unions, City managers, and most importantly, by civic employees. Over 350 civic personnel, both union and management, have used the services. The Board of Directors has considered a variety of options to deal with the resulting financial pressures, including the introduction of user fees, maximum annual payments in the program, and increased employee/employer contributions. After consideration, it was determined that the most appropriate response was to raise the contribution level. Currently each civic employee contributes \$1.00 per pay period, or \$24.00 per year. It is proposed that this amount be increased to \$2.00 per pay period. Since the inception of EFAP in January, 1990, the City of Saskatoon has matched the employees' contributions. The 1991 operating budget identified a cost of \$35,900. Assuming approximately the same number of employees, the proposed 1992 operating budget contribution would therefore be \$71,800.

The proposed employee contribution increase has been approved by most civic bargaining

units. Any additional contribution by the City of Saskatoon is predicated on the unanimous support of all unions.

Report of Fire Chief, October 10, 1991:

"On September 4, 1991, City Council approved the Fire Department Amendment Bylaw No. 7241 which contained, in part, Section 9.1 dealing with the prohibition of parking propane fuelled vehicles in any underground and enclosed parking facility attached to a major residential, business and personal services or mercantile occupancy.

At the time City Council approved the Bylaw Amendment, it was resolved that the matter of Stop Fill Valves on propane tanks be referred to the Planning and Development Committee for further review.'

In response to the Resolution, the Fire Chief will demonstrate the Stop Fill Valves to the Planning and Development Committee. In addition, the following points should be considered by the Committee:

- a) The Stop Fill Valves cannot be detected on vehicles so equipped, therefore, enforcement of the Bylaw becomes impossible if they are to be allowed into enclosed public parking areas.
- b) Stop Fill Valves have only been installed on vehicles in Saskatchewan since the

- c) Stop Fill Valves only provide for protection against purges from overfilling. No protection is provided against releases from possible mechanical damage nor protection from increased intensity from a fire in the vehicle or other source which may impinge on the tank."

Attached, as background information, is a copy of Clause C3, Report No. 26-1991 of the City Commissioner, as referenced above.

Your Committee has met with Fire Chief Hewitt to discuss this matter and

**3. Dutch Elm Disease
(File No. CK. 4200-4)**

Report of General Manager, Civic Buildings and Grounds Department, October 2, 1991:

"Introduction

Dutch Elm Disease (DED) has been identified in a number of areas in Saskatchewan. This disease has the ability to kill thousands of American Elm trees each year. Since a relatively large proportion of Saskatoon's urban forest consists of elm trees, the effect of DED on our community could be devastating.

Currently, the most severe infestations of DED in the province are found in native elm stands in the valleys along the Carrot River and in the vicinity of Cumberland House. To the southeast, there is a severe infestation along the Souris River Valley, south from Estevan to the U. S. border. In each of these areas, thousands of trees have been killed. Smaller infestations of DED are found to the north of Grand Coulee near Regina, in the Town of Shaunavon, and in the Qu'Appelle River Valley near the Manitoba border. Most recently, the existence of DED has been confirmed within Wascana Park in Regina.

Much of the infection has been discovered this year and this seems to suggest that while it

has not been fully detected, DED appears to be very widely spread throughout the province. It is no longer a question of if the disease will infect Saskatoon's elm trees, but rather of when this will happen (if it hasn't already) and of how prepared our community will be to reduce the damage that DED is capable of doing to elm trees on public and private properties.

How the Disease is Spread

Elm bark beetles are insects which are specifically attracted to American Elm trees. The beetles carry the disease fungus from tree to tree through their breeding and feeding activities. The bark beetle lays its eggs in dead and dying elm wood. It transfers the fungus to the eggs through the egg-laying process.

When a tree becomes infected with the disease, the tree reacts by sealing off the infected portions. Unfortunately, the disease moves so quickly within the tree that the tree eventually seals itself off so completely that water and nutrients are cut off to its crown and the tree dies.

Typically, a tree infected in the spring will first show 'flagging' symptoms. Flagging includes the yellowing of the tree's leaves, accompanied by wilting of the leaves in a few branches. Over the summer, the disease will progress and by autumn, the tree will be completely dead.

The Disease's Implications for Saskatoon

Saskatoon has an estimated 50,000 Elm trees on the City's boulevards, in its public parks and cemeteries, and on residential properties. If left uncontrolled, DED could kill the majority of these trees within a decade. The core neighbourhoods and parks, in particular, would be devastated, since over 60% of trees in these areas are of the elm variety. The collective replacement cost of these trees is estimated at \$25 million.

Since there is no cure for DED, many North American cities which have recognized the implications of this disease have taken action which tries to control its potential for spreading within the community. For example, the City of Winnipeg has implemented strict control measures which have been able to reduce to approximately 2% per year the number of boulevard trees that are being removed as a result of this disease. Without this action, Winnipeg's removal rate would be substantially higher.

The Elements of a DED Control Program for Saskatoon

A control program in Saskatoon needs to be undertaken through a strategy which emphasizes broadly-based community involvement. The City does not have the resources or sufficient time to tackle this problem alone and therefore, requires the support and assistance of all residents. DED is a community-wide concern because it involves trees on boulevards and parks, as well as in residential yards.

A DED control program in Saskatoon should include both short- and long-term components. The short-term components refer to those activities which involve immediate action, while the long-term components refer to actions that are required when the existence of DED in Saskatoon has been confirmed.

The short-term program includes implementing the following actions:

1. Public Relations

First, the public must be warned not to bring elm firewood into the city. If any elm firewood has been brought into Saskatoon, it should be burned or buried immediately. This message must be brought to the attention of the public through press releases, advertisements, and possibly highway signs.

Second, the public needs to be made aware of the disease's symptoms so that they can help detect the problem or so that action can be taken to remove the infected trees. This can be accomplished through press releases, advertisements, and brochures.

Third, the public must be encouraged to take better care of their American Elm trees. This includes regular watering, pruning, and fertilization.

To date, the Civic Buildings and Grounds Department has placed an advertisement in The Star-Phoenix which advises the public that elm firewood should not be brought into Saskatoon. There is a concern that the timing of this advertisement was not early enough to ensure that the public was sufficiently aware of the need to consider the type of firewood that is being brought into our city. With respect to the other types of public information messages which have been identified in the preceding paragraphs, the Department has not been able to take any action this year because of insufficient budgetary resources.

2. Pruning

Pruning is critical to the control of DED because it removes the breeding sites for the elm bark beetle and it invigorates the tree's growth. As the Committee is aware, the Civic Buildings and Grounds Department has for several years been requesting additional funding in order to expand the City's very inadequate pruning program. This year, City Council agreed to add \$35,000 to the Department's budget (although its original request was for \$100,000), thereby increasing the pruning frequency from 1,000 to 1,350 trees per year. The program should involve 6,800 trees per year in order to prune our larger trees (i.e. those in excess of 15 feet) at least once every seven years. Therefore, in order to meet acceptable horticultural standards regarding the maintenance of the City-owned trees, substantially more funding will be required for tree pruning.

3. Basal Spraying

An estimated 80% of all elm bark beetles overwinter in the trunk of elm trees. In autumn, they crawl or fly down to the base of the tree, and burrow beneath the bark to hibernate.

Under basal spraying, an insecticide is applied to the lower 1.5 meters of the elm tree. The insecticide has a residual nature such that when the beetle burrows into the bark in the autumn, it will contact the insecticide and die. This treatment needs to be repeated every two years. Currently, the City does not have any funding to undertake basal spraying of Saskatoon's elm trees.

4. Monitoring

This refers to inspecting the trees for the symptoms of Dutch Elm Disease. If infection is suspected, a sample of the tree's branches is taken for laboratory analysis in order to confirm the existence of DED. Currently, the Civic Buildings and Grounds Department completes a single inspection, annually, of all City-owned boulevard and park trees. Now that the threat of DED is only 'hours' away from Saskatoon, monitoring needs to be improved through on-going and more frequent inspections of not only boulevard and park trees, but also elms which are located on private property. Trees where the amount of deadwood exceeds 50% should be tagged for removal because they can act as breeding sites for the elm bark beetle.

The monitoring should also provide for the inspection of elm firewood in residential areas. These piles can also become breeding sites for the beetle.

The Civic Buildings and Grounds Department's budget is only sufficient to accommodate the annual inspection of boulevard and park trees. A more thorough and more frequent inspection will require additional resources.

A long-term program will also be necessary to control the disease when it infects Saskatoon's tree population. In addition to the four short-term components mentioned above, an ongoing monitoring and removal program will be necessary. In other words, trees with DED symptoms will be sampled and marked. If the lab test verifies the existence of DED, then the tree would be immediately removed. In doing so, the infected elm bark beetles are destroyed, and the tree could not be used as a breeding site in the following year. This continued identification and removal program is necessary to control the spread of the disease.

Unfortunately, a control program for DED is expensive. On the other hand, letting the disease spread, uncontrolled, into the city could have even more expensive implications, if decision is subsequently made to try to stop the disease from destroying all of the community's elm trees.

Province-wide Action Recommended by the Saskatchewan Dutch Elm Disease Committee

A Saskatchewan Dutch Elm Disease Committee has been established which consists of representatives from several municipalities, the Saskatchewan Urban Municipalities Association, and the Saskatchewan Association of Rural Municipalities, as well as from the Federal and Saskatchewan Governments. The City of Saskatoon is represented on this Committee by Mr. Dave Domke, Supervisor of Arboriculture in the Civic Buildings and Grounds Department.

This Committee has proposed that a cost-sharing arrangement should be established involving municipalities and the Provincial Government in order to implement an expanded DED control program. This approach is similar to the one which already exists in Manitoba. In this regard, City Council should consider passing a resolution which urges the Saskatchewan Government to establish such a cost-shared program.

The Saskatchewan Dutch Elm Disease Committee is also discussing draft regulations under The Pest Control Act. Provisions are being considered which would allow an appointed inspector to travel onto private property in order to check and sample for DED in elm trees and firewood, as well as to enforce the removal of infected trees and firewood.

Conclusion

DED is a devastating disease. Its impact on Saskatoon's trees is far greater than, for example, the existence of cankerworms which are currently receiving considerable public attention and action.

DED is a community-wide problem since it involves both City-owned and privately-owned trees. Not controlling DED would result in thousands of dead trees. Since many of these trees are on the City's property, the removal costs would be extremely high. The adoption of control measures would limit the loss of our trees to DED and would enable the replacement our elm trees with those of a different species. The Civic Buildings and Grounds Department intends to incorporate a provision within its 1992 Operating Budget submission to implement the short-term control strategies which have been identified in this report."

Your Committee has met with representatives of the Civic Buildings and Grounds Department and wishes to note that the Saskatchewan Dutch Elm Disease Committee is providing an excellent liaison for municipal officials to monitor the spread of the disease and to coordinate a public education program. In light of the fact that this disease could wipe out all elm trees in the province if left untreated, your Committee has requested that the Administration prepare a long range plan to combat Dutch Elm Disease in the City and include an amount for this Long Range Plan in the 1992 Operating Budget.

As well, there are no other sources of funding and the City's policy requires at least 50% must be raised elsewhere. The Committee has previously dealt with this group and recognizes the difficulty the group has in developing an appropriate business plan on the project. It had been suggested that the group meet with Mr. Les Bird, of our Personnel Services Department, who could assist them in developing a plan to obtain potential funding from the Federal and Provincial Governments. To date, this offer of assistance has not been taken up."
