**B1) Fringe Festival Residential Parking Permit Program
Nutana Neighbourhood
(File No. 6120-2)**

RECOMMENDATION: that the direction of City Council issue.

At its meeting on July 17, 2006, Council asked that a bylaw be prepared extending the area where a Residential Parking Permit is required for the Fringe Festival. Council asked that the area be expanded to include an additional three blocks east and west of Broadway Avenue. Attached please find Bylaw No. 8524 which does that, except that to the east, we have ended the proposed area at Clarence Avenue.

Also attached, for comparison purposes, is the map showing the existing residential parking area.

In discussions with the General Manager, Infrastructure Services Department, the concern was raised that the new proposed area might be too large, as it relates to its effect on the Fringe Festival. We have therefore enclosed, as an alternate bylaw, Bylaw No. 8525, which extends the area one block further east and west of Broadway Avenue.

Mr. Robert Wyma, 25th Street Theatre, expressed opposition to an expanded parking restriction during the Fringe Festival and indicated that the 25th Street Theatre will work with the parties involved on resolving any issues post festival.

Dr. Dan Pennock, Nutana Community Association, indicated that the current two-block radius only pushed the parking problems further into the area and noted that the Association did not have an opinion on the proposed five-block radius as they have not discussed that proposal.
