City Clerk Sproule declared the 2016 Inaugural Meeting of the City of Saskatoon City Council open and requested that everyone remain standing for the National Anthem, which was performed by the University of Saskatchewan Greystone Singers.

City Clerk Sproule advised that on October 26, 2016, a civic election was held following procedures set out in *The Local Government Elections Act* and by a majority vote, Charlie Clark was elected Mayor of The City of Saskatoon.

The Honourable Justice R. Shawn Smith, Saskatchewan Court of Queen's Bench, administered the Oath of Office to Charlie Clark, placed on his shoulders the Chain of Office of the Mayor of the City of Saskatoon, and charged him with the duties of the Chief Executive Officer of the City.

The City Clerk then called forward Councillors-elect Hill, Gough, Iwanchuk, Davies, Donauer, Block, Loewen, Gersher, Dubois, and Jeffries, individually, who took their Oath before the Mayor, following which His Worship the Mayor charged the Councillors with the responsibility to employ themselves in their office in a truthful, faithful and impartial manner, and welcomed them as members of City Council.

After salutations were extended, the Councillors took their seats and His Worship the Mayor took his seat on the dais. His Worship the Mayor invited the members of the Administration to take their seats within the Bar as follows: City Clerk Sproule, City Manager Totland, City Solicitor Warwick, General Manager Community Services Grauer, General Manager Corporate Performance Gryba, Chief Financial Officer and General Manager Asset and Financial Management Tarasoff and General Manager Transportation and Utilities Jorgenson.
