6. UNFINISHED BUSINESS

6.1 2016 Budget Revisions - Saskatoon Public Library (Files CK. 1711-6)

The City Clerk reported that City Council, at its Preliminary Business Plan and Budget Meeting held on November 30, 2015 considered the Saskatoon Public Library's 2016 Operating and Capital Budget Submission and resolved that the Public Library Board bring back a more detailed explanation on how the proposed FTE's translate into continuous improvement and long-term efficiencies.

7. QUESTION PERIOD

Councillor Paulsen excused herself temporarily from the meeting at 1:25 p.m. during Question and Answer Period.

7.1 Councillor P. Lorje – Lead Water Lines

Councillor Lorje asked if the City is at risk with respect to its lead water lines in light of what is happening in Flint, Michigan and questioned what it would take for a more aggressive lead line replacement program.

A/City Manager Jorgenson indicated that some research has been done regarding the Flint, Michigan incident and assured the public that the City of Saskatoon is not at risk. Lead lines are common in many municipalities in North America and the circumstances are unique in Flint.

Regarding an accelerated lead line replacement program, the Administration is looking at increasing the 2016 budget for lead line replacements using a portion of any surplus in the Water and Wastewater Utility, should there be any. In 2017 City Council has the opportunity to set the rates. A report is intended in the first quarter of this year outlining a broad strategy for what an accelerated lead line connection program would look like including costs.

7.2 Councillor P. Lorje – Relining the Lead Cell at the Landfill

Councillor Lorje asked if the City monitors, and if so, where does the City monitor to ensure that lead from the landfill is not getting into the river and is there any danger of Saskatoon water supply being compromised.

A/City Manager Jorgenson advised that there are two intakes, a primary intake unaffected by anything from the landfill, and a secondary intake at the Water Treatment Plant only used in an emergency. He addressed risks of leachate seeping into the river from the landfill ensuring that any risks are mitigated. There is no evidence of any seepage and the City monitors for any presence of seepage.

7.3 Councillor Z. Jeffries – Snow and Ice Level of Service

Councillor Jeffries asked what, if anything, could the City have done differently to improve the icy conditions on Circle Drive with the recent temperature change.

A/City Manager Jorgenson indicated that more sanders could have been on the road at that time and noted that every combination of sanders and staff members available were deployed. There were some sanders that were in for repair. He further noted that a direct liquid application would not have been effective due to the plummeting temperatures.

7.4 Councillor R. Donauer – Street Sanding Resources

As a result of the response to Councillor Jeffries' question regarding the recent icy conditions on Circle Drive, Councillor Donauer asked if maintenance of sanders is an issue.

A/City Manager Jorgenson indicated that he is not aware that there is a significant or repetitive issue with the maintenance of sanding equipment. He further indicated that with the recent icy conditions on Circle Drive, the City was also short of people to work. He undertook to follow up with Public Works and Fleet and will provide an information update report in due course.


