## BYLAW NOTICE

### PROPOSED AMENDMENT TO CANNABIS BUSINESS LICENSE BYLAW – BYLAW NO. 9716

Saskatoon City Council will consider a report from the City Solicitor on **Monday, August 31, 2020 at 6:00 pm in Council Chambers City Hall (222 3<sup>rd</sup> Avenue N)**, recommending that City Council consider Bylaw No. 9716, *The Cannabis Business License Amendment Bylaw, 2020*, which will:

- Amend subsection 6(1) to reduce the initial license fee for a cannabis production facility and a cannabis retail store from \$20,000 to \$4,500; and
- Change the spelling of "license" to "licence" and reformat the definition section to align with current drafting practices, including the removal of footnotes.

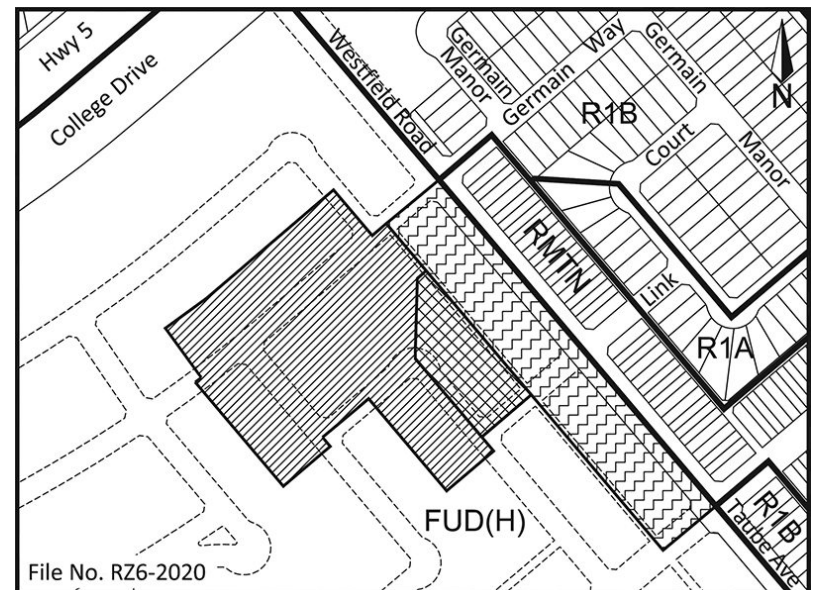
## ZONING NOTICE

### BRIGHTON NEIGHBOURHOOD

### PROPOSED ZONING BYLAW AMENDMENT – BYLAW NO. 9718

Saskatoon City Council will consider an amendment to the City's Zoning Bylaw (No. 8770) proposed by BDM Enterprises Ltd. to rezone lands adjacent to Westfield Road in the Brighton neighbourhood. By way of Bylaw No. 9718, The Zoning Amendment Bylaw, 2020 (No. 18), the subject lands are proposed to be rezoned from FUD – Future Urban Development District subject to the Holding Symbol (H) to R1A - One-Unit Residential District, R1B - Small Lot One-Unit Residential District and RMTN – Townhouse Residential District.

**LEGAL DESCRIPTION** – Portion of the North ½ of Section 30, Township 36, Range 4, West of the 3<sup>rd</sup> Meridian.



### PROPOSED ZONING AMENDMENT

- From FUD(H) to R1B
- From FUD(H) to R1A
- From FUD(H) to RMTN

**REASON FOR THE AMENDMENT** – The proposed rezoning will provide for future subdivision and development as provided for on the approved Brighton Neighbourhood Concept Plan.

The R1A and R1B Districts will provide for one-unit residential development as well as related community uses and the RMTN District will provide for residential development in the form of street townhouses as well as related community uses.
