Residents of northern village flee wildfire

BUFFALO NARROWS A wildfire near the northern Saskatchewan community of Buffalo Narrows has forced the village to issue a state of emergency.

Mayor Sandy Ericson said Monday that many residents evacuated the community because the smoke is affecting their health.

She said the loss of electricity has also made it difficult for people trying to stay cool.

"It's hot, so it's not a good combination," Ericson said. "We're just trying to keep everybody who is here in the community safe and hopefully we can get more vehicles out.'

 $The fire in the \, Buffalo\, Narrows$ region reached 25.000 hectares. the Saskatchewan Public Safety Agency said. It jumped the only highway that leads into the village, causing it to close down.

Power lines have also caught fire, causing the power outage.

Ericson said dozens of people left by bus or took their vehicles before the highway closed.

She said the village is working with the Saskatchewan Public Safety Agency to escort more people out safely through the highway so they can head south for services.

Those who left have been given accommodations in Lloydminster, while others are staying with family in Prince Albert, Meadow Lake or Saskatoon, she

The fire so far isn't threatening homes in the village, she added.

"We do have some housing that we may have to take some precautions for, but right now (the fire) is going the other way,"

Tire recycling plans put on pause for provincial review

The provincial government is tapping the brakes on changes to Saskatchewan's tire-recycling market.

The province announced Monday that Premier Scott Moe has engaged Cam Swan, a former deputy minister of environment, to work with the Ministry of Environment and Tire Stewardship Saskatchewan (TSS), the industry non-profit that oversees used tire collection.

Swan is to "review procurement practices and assess future needs of tire recycling and processing, and to provide recommendations to the minister," the announcement states

The review is to be completed sometime this summer. In the meantime, a request for proposals for a new tire processor for the northern portion of the province is to be put on hold.

TSS recently awarded a contract to U.S.-based Crumb Rubber Manufacturers (CRM) for a tire processing facility to be set up in Moose Jaw. The move came with a guarantee that CRM would receive all used tires collected in the southern portion of the province, as opposed to the previous system, which allowed dealers to choose where used tires went.

TSS CEO Stevyn Arnt previously

said the move was meant to reduce freight costs and lower the environmental impact of shipping tires from southern Saskatchewan to the outskirts of Saskatoon.

The arrangement drew strong reaction from Shercom Industries, which has for years operated Saskatchewan's only tire processing facility in the Corman Park Industrial Area a few kilometres north of Saskatoon. Shercom's contract with TSS expired in 2020; the last in a series of short-term extensions ran out at the end of April.

With the supply of used tires nearly cut in half, Shercom president Shane Olson last week said his company had cut dozens of jobs, as its multimillion-dollar tire processing operation was no longer viable.

He said the tire processing plant would be shut down completely once Shercom's existing inventory was used up. From there, he said the company would then have to rely on rubber purchased from outside the province for its ongoing manufacturing business, which produces items including driveways, patio tiles and landscaping

Olson also stated that Shercom would not bid on the now-shelved plan for a processor for the northern half of the province, and cast

OFFICIAL COMMUNITY PLAN NOTICE Proposed Official Community Plan Amendment – Bylaw 9839

Saskatoon City Council will consider an amendment to the Official Community Plan Bylaw, 2020 (Bylaw No. 9700) proposed by AODBT Architecture + Interior Design on behalf of S.S. Pacific Imports Inc. By way of Bylaw No. 9839, The Official Community Plan Amendment Bylaw, 2023 (No .2), a new "High Density Mixed Use" land use designation and supporting objectives and policies would be added to the Official Community Plan. High Density Mixed Use may be located within the Downtown, City Centre, and/or Strategic Infill Areas.
