This letter is to notify you of the upcoming dates that the proposed Willows Concept Plan amendment and accompanying amendments to the City of Saskatoon Official Community Plan Bylaw No. 9700 and Zoning Bylaw No. 8770 will be reviewed by the Municipal Planning Commission and considered by City Council at a Public Hearing.

The Willows Concept Plan amendment submitted by Dream Development proposes a reconfiguration of the west portion of the Willows Neighbourhood, including changes to land uses, street network, service networks, the addition of public park areas, alterations to the golf course, addition of a 7.4 hectare parcel adjacent to Cartwright Street, and provision for the development of fee-simple lots (separately titled lots not part of a condominium plan) within the amendment area. The amendment also provides for a commercial site and neighbourhood node located west of and adjacent to Cartwright Street, near the existing clubhouse, to accommodate a hotel and limited commercial uses.

The application also includes proposed amendments to the Official Community Plan (OCP) Land Use Map, a minor OCP text amendment, amendments to the Direct Control District 4 (DCD4) regulations contained in the City of Saskatoon Zoning Bylaw, and a zoning map change to include the north development area.
