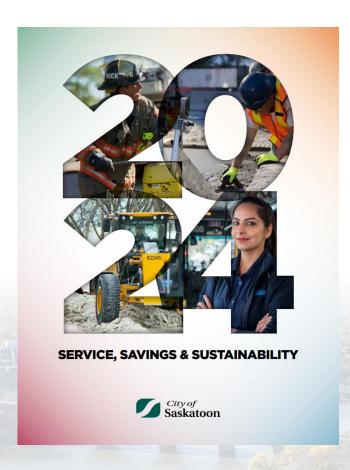

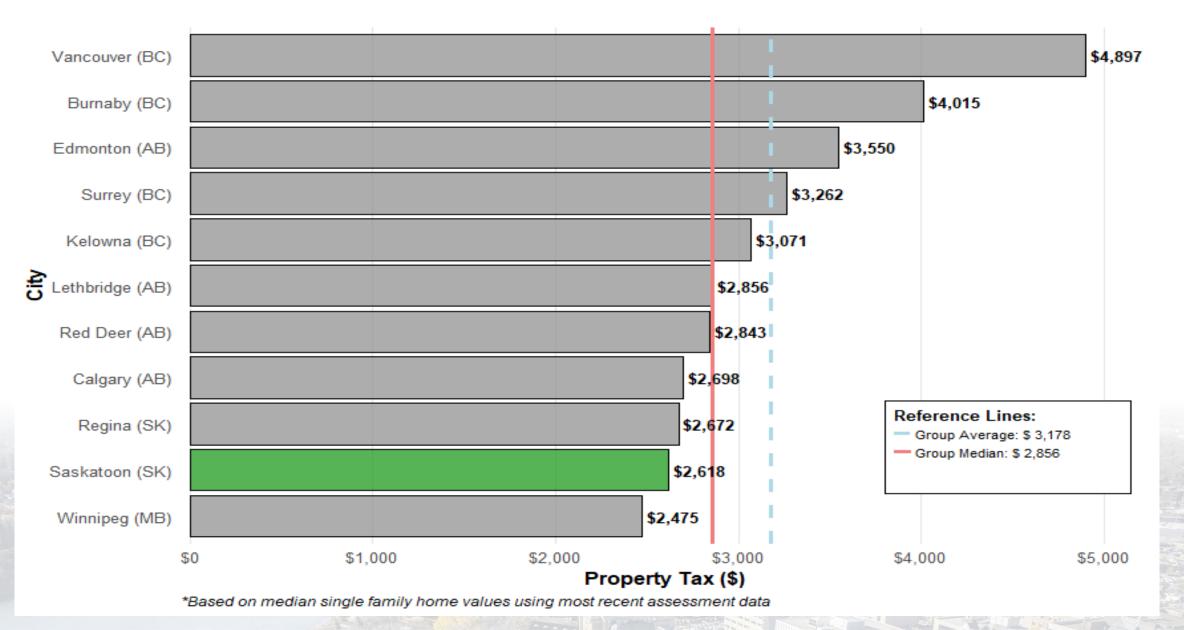

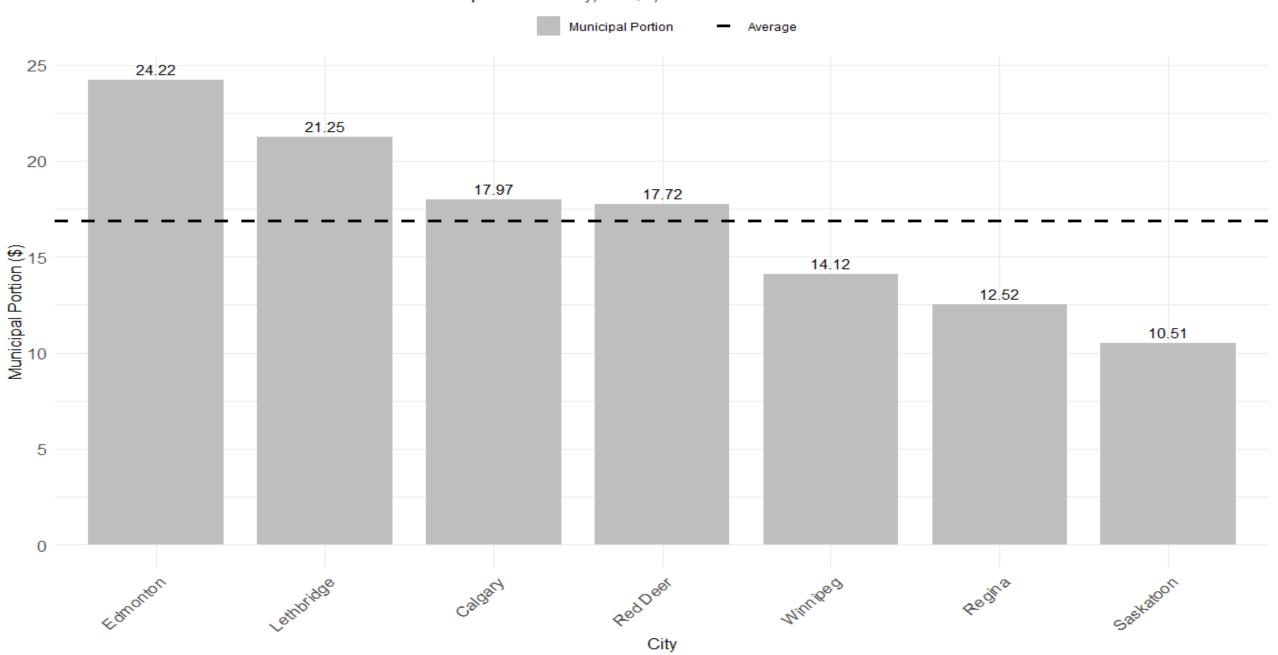
2025 Property Taxes by City

Municipal Portion Only, Per \$1,000 of Taxable Assessed Value





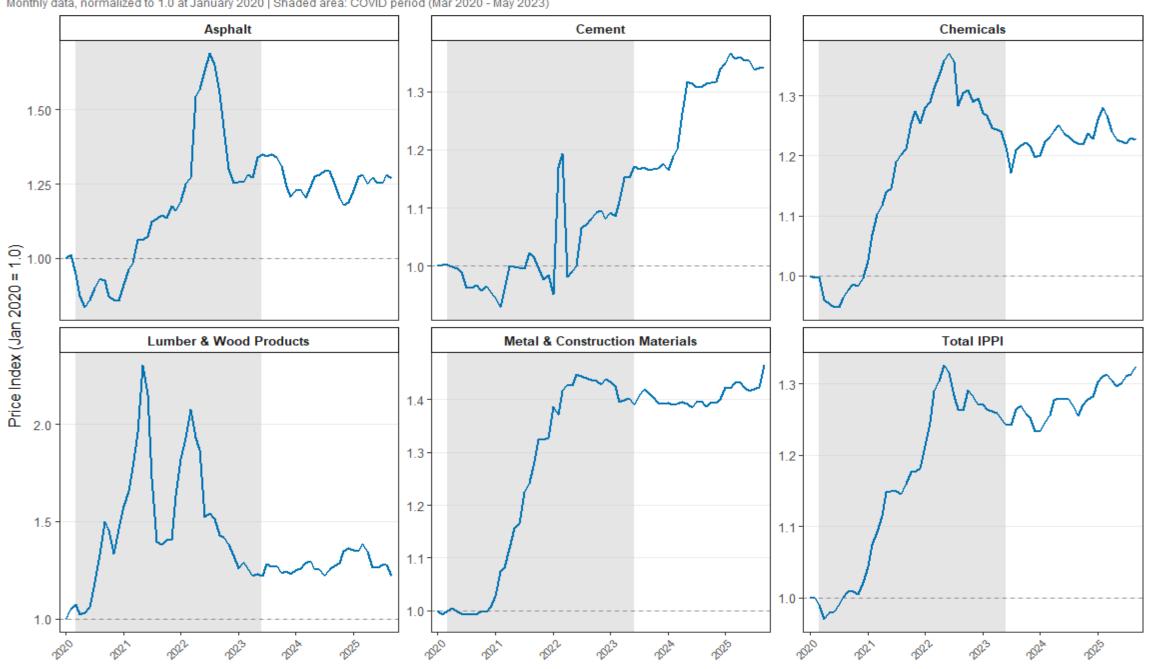

Monthly data, normalized to 1.0 at January 2020 | Shaded area: COVID period (Mar 2020 - May 2023)



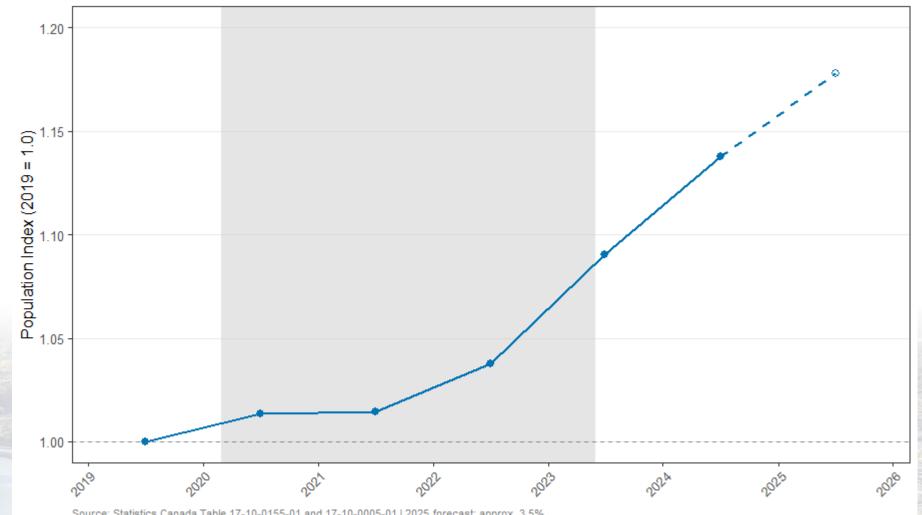

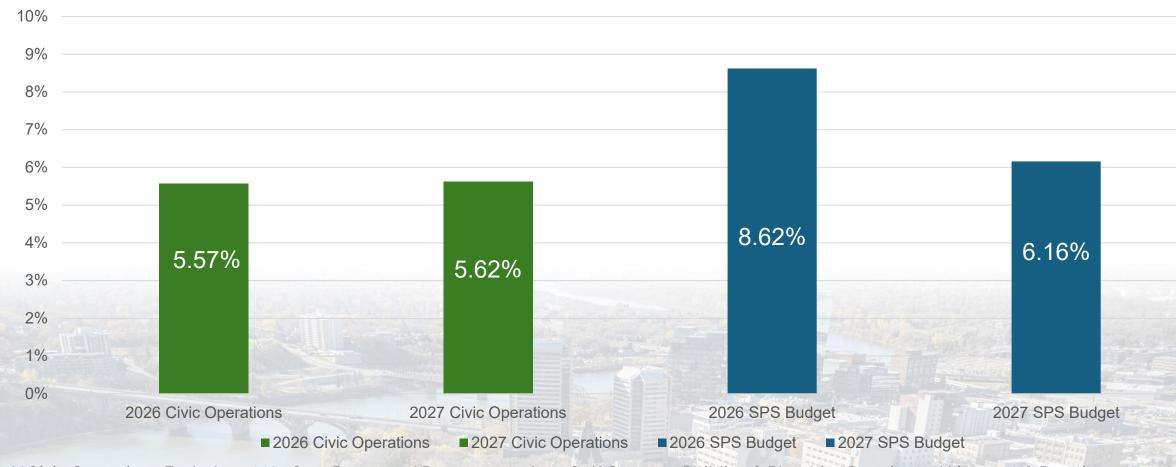

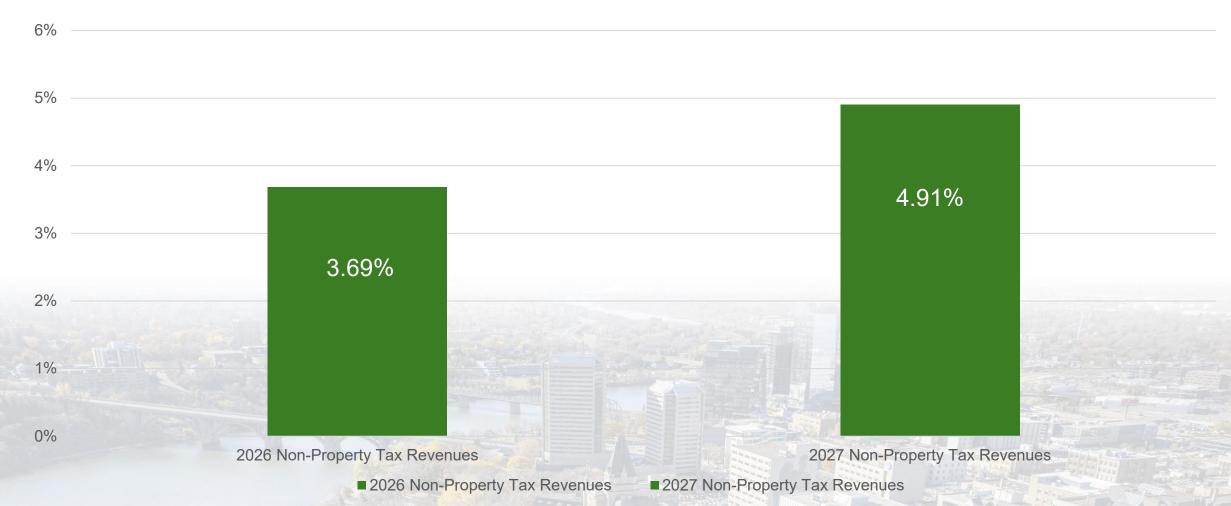

Next Steps

Budget Agenda to be released on November 19

- Will include a "Civic Operating Budget Scenarios" report that outlines over 100 potential options to lower the municipal property tax requirement in 2026 and 2027
- As directed by City Council in June 2025, if all options were selected, would achieve the targeted municipal property tax rates of 4.90% in 2026 and 2.34% in 2027.

Budget Deliberations Begin on November 25 and will be Live-Streamed
