GROUP GOLF BOOKING REGULATIONS

- 1. Groups that have overpaid will only be entitled to a refund if they have contacted the Golf Course Assistant at least 72 hours prior to their booking. Refund requests with less than 72 hours' notice may be processed if cancelled bookings can be rebooked prior to the event and are at the discretion of the Golf Course Assistant.
- 2. Groups not prepaying their green fees, or not notifying the pro shop at least 72 hours prior to their event will have their bookings cancelled with no refunds for any prepaid fees.
- 3. In the event of cold and/or inclement weather group bookings must go ahead as scheduled. Rainchecks **may** be issued in part or in full should the event be cancelled due to inclement weather on the day of the event. These decisions will be at the discretion of the Golf Course Assistant. All attempts will be made to reschedule groups that are cancelled prior to issuing Rainchecks. Our regular Raincheck policy is in effect once a group is already on the golf course and the weather causes the golfers to discontinue play. This policy allows for full Rainchecks for those that have not completed 3 holes, and 9-hole Rainchecks for 18-hole players that have not completed 3 holes on the back 9.
- 4. On a weekend or legal holiday, 18-hole draw start events cannot begin before 9:00 a.m. on an 18-hole course without approval from the Golf Course Assistant.
- 5. The event co-ordinator is responsible for supplying a current list of players, grouped in foursomes at least 48 hours prior to the event. We would appreciate at least 5 days' notice for events that may require: Hole in One Yardage Requirements, Tables, Chairs, Hole and Tee Marker Placement Requests, Sponsor Sign Placement, Closest to the Line Competitions, and Long Drive and Closest to the Pin Markers.
- 6. Unacceptably slow players will be asked to play the forward tees or pick up and move forward without completing a hole to ensure proper pace of play.
- 7. Golf course rules and proper etiquette as defined by Golf Canada, the City of Saskatoon, and the Saskatchewan Liquor and Gaming Authority must be adhered to and will be strictly enforced. The City of Saskatoon Municipal golf courses reserves the right to discontinue alcohol service to any guest who appears to be intoxicated.
- 8. Wildwood and Silverwood Golf Courses are non-licensed facilities. Alcoholic beverages on these premises are not permitted at any time. Holiday Park Golf Course is a licensed facility. Only alcoholic beverages purchased from the Beverage Cart, or the Lounge may be consumed on the golf course, as prescribed by the Saskatchewan Liquor and Gaming Authority regulations. Beverage cooler chests are generally not permitted on the golf course. Those that are allowed or are found to be on the course will be subject to inspection by our Golf Course Attendants. Those that insist on attempting to or consuming their own alcoholic beverages on the golf course, or it's premises, will be removed without the possibility of any refunds for prepaid fees and/or rentals, and subject to court-imposed fines and penalties up to \$10,000.
- 9. Golfers are expected to always wear proper golf attire including a full-bodied shirt and suitable shorts or pants. Gentlemen are recommended to wear shirts with sleeves; women may wear sleeveless shirts. Shirts must be always worn. Exposed midriffs, strapless or halter tops, and bathing suits are not permitted. For your own personal safety, suitable footwear must be always worn which may include soft-spiked golf shoes, running shoes, sandals, or soft-soled shoes. To prevent damage to the golf course, no heels over one half inch or boots of any kind are permitted. Playing in bare feet is not permitted.
- 10. City of Saskatoon Smoking Bylaw No.8286 that includes "Outdoor Public places operated by the City" Prohibits Smoking and Vaping on the golf courses property, and is subject to fines up to \$5,000 for individuals and proprietors guilty of contravening the Bylaw. It is expected that all patrons, visitors, and employees of our municipal golf courses will obey signage and adhere to the City of Saskatoon Bylaw to ensure our facilities remain smoke free.
- 11. All 18-hole players must proceed to Hole #10 without delay after finishing Hole #9, maximum break of 5 minutes.
- 12. The City of Saskatoon's Golf Course Superintendent reserves the right to close the course when circumstances require. In the case of a course closure the event organizer will be given a Refund for the paid number of players and powercarts.
- 13. The City of Saskatoon and its municipal golf courses reserve the right to cancel or suspend playing privileges, without refund, to anyone or the entire group for non-compliance of any of the above rules and regulations, or for any action which is abusive or offensive to the property, facility, its patrons, and employees.

In consideration of providing group booking services, we hereby release the City of Saskatoon from all claims. We agree to protect, hold harmless and indemnify the City of Saskatoon, their employees and agents against all losses, damages, claims, demands, and actions arising directly or indirectly in any matter whatsoever in connection with the tournament and shall pay all costs, expenses of any such claim or litigation. We further agree to abide by the golf course regulations and assume financial liability for any damage to the facilities, furniture and equipment or the loss of furniture and equipment when caused by negligent or abusive treatment.
