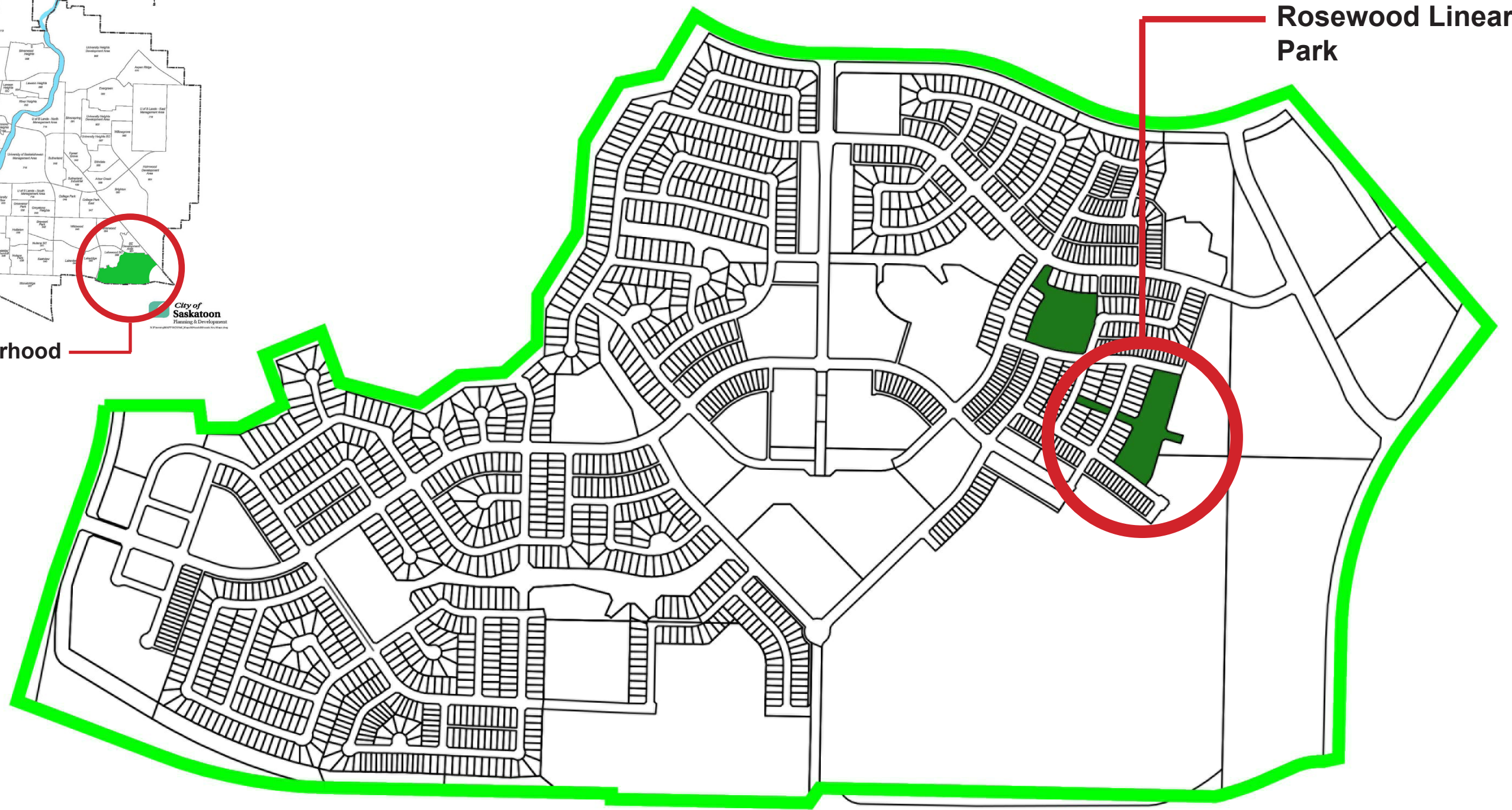
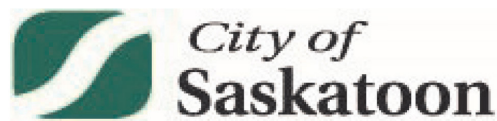

### Design Program

Rosewood Linear Park is intended to be a passive recreation park; one that is open to all community residents, and includes specific components for families with young children. The design program includes the following:

- Tot lot (play equipment for 2-5 year olds).
- Open play area
- Lighted pathway system connecting residents to the park's features, and providing linkages through the neighbourhood.
- Plant material, integrating in with the park features.
- Irrigation
- In addition, the park is to contain surface runoff from a major storm event within the park.



**Tot Lot**

The tot lot is intended for young families with children between the ages of 2-5. The tot lot is set back from the street to provide separation between children and vehicles, but is close enough to the street to be easily monitored (to deter inappropriate use).

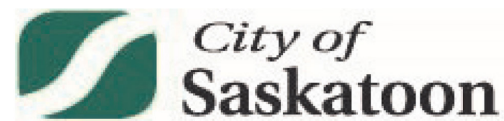
Seating is provided, overlooking the tot lot and there are two small open spaces adjacent to the tot lot to provide open play.

The tot lot is set back from the residential lots, and plant material provides some screening to separate the two.



**Open Play Area**

The “open play area” is an unallocated space providing the residents the opportunity to use it as they see fit (unallocated means that it is not a programmed sports facility available for booking).

**Lighted pathways**

Rosewood Linear includes 2.4m wide asphalt pathways. All of the pathways include lighting.

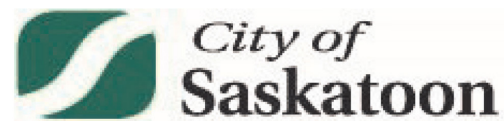


**Planting**

Planting is a mixture of trees and shrubs.

Adjacent to pathways, planting will be restricted to large canopy deciduous trees and low shrub material in order for pedestrians to maintain awareness of their environment as they move along the pathways.

While coniferous material adds colour to the winter environment, the density of its structure can impede vision through the park, therefore this plant material is set back from pathways.

# Rosewood Linear Park Proposed Conceptual Design: 24 January 2022 Lighted Pathways - Planting Design



**Flooding**

Rosewood Linear Park is designed to contain a 1 in 100 year storm event within the park (i.e, surface runoff from the park is designed to be contained within the park). This temporary flooding is kept away from most of the pathways and the tot lot.

**Drainage:**

Following a major storm event, the water will be drained away through catch basins within the park - following a 1 in 100 year event, the storm sewer system may take 6 - 8 hours to drain the park.
