Liquid Domestic Waste Haulers are required to abide by the Water Security Agency's <u>EPB 349 – Liquid Waste</u> <u>Disposal Regulations</u>.

Terms and Conditions

- 1. Each vehicle used for the purpose of hauling wastewater to a City of Saskatoon operated disposal facility must be registered and have a functional PIN.
- 2. No vehicle without a valid PIN will be permitted to use any of the City of Saskatoon disposal facilities.
- The City of Saskatoon may deactivate a PIN where the Applicant has neglected to pay any associated fees
 or violated any provision pursuant to *The Sewer Use Bylaw, No. 9466* or for any other reasons that the City
 of Saskatoon may deem appropriate.
- 4. The Applicant shall be responsible for all charges and conduct arising from the driver or vehicle associated with a registered PIN.
- 5. Upon the first visit to any of the disposal facilities drivers are required to undergo orientation for proper use of the facility.
- 6. Failure to comply with applicable City of Saskatoon Bylaws may result in suspension and/or cancelation of the Trucked Liquid Waste Hauler Permit and/or from the use of City of Saskatoon disposal facilities.
- 7. Wastewater collected from industrial/commercial/institutional business shall not be mixed with wastewater from any other business.
- 8. Nothing in this document exempts a person from complying with all applicable provincial or federal legislation or standards.
- 9. All hauled wastewater is subject to inspection, sampling and/or analysis.
- 10. The Applicant consents to allow the City of Saskatoon to provide analytical information to third parties, where required by law, for determining whether the hauled wastewater can be accepted or not at any of the City of Saskatoon disposal facilities or when the City of Saskatoon deems necessary for the purpose of ensuring compliance with applicable law.
- 11. All users acknowledge and understand that they are attending the facility at their own risk and freely and fully accept responsibility for the risks, dangers and hazards present which may result in bodily injury or death.
- 12. The Applicant shall pay for facility clean-up resulting from equipment leaks or disposal spills caused by the Applicant or any driver or vehicle associated with this application.

Facility Usage

- 13. All users of the City of Saskatoon disposal facilities shall adhere to The Sewer Use Bylaw, No. 9466.
- 14. Only wastewater that meets the requirements of *The Sewer Use Bylaw, No. 9466,* shall be disposed at a City of Saskatoon disposal facility.
- 15. All loads that exceed restricted limits set out in Schedule B of *The Sewer Use Bylaw, No. 9466* must be approved by the City of Saskatoon prior to discharge.
- 16. No person, except the vehicle operator, shall enter a City of Saskatoon disposal facility for the sole purpose of disposing of wastewater.
- 17. Vehicles entering the facility are permitted to remain in the wastewater disposal facility only so long as reasonably required to unload the wastewater contained in the vehicle.
- 18. Hydrovac waste is not permitted at any City of Saskatoon disposal facilities unless written permission has been granted.

Misrepresentation/Misuse of Permits

- 19. PIN codes are issued to a specific vehicle. Use of a PIN code with a different vehicle, without prior consent from the City of Saskatoon may result in suspension and/or termination of the Trucked Liquid Waste Hauler Permit and/or from the use of City of Saskatoon disposal facilities.
- 20. In the event the Applicant changes its vehicle(s) from the vehicle(s) identified on this application form, then the Applicant shall complete the appropriate City of Saskatoon form identifying the information associated with the new vehicle and the assigned PIN code(s).

The City of Saskatoon reserves the right to amend or modify these terms and conditions at any time by mailing notice of such amendment or modification to the Applicant.
